Public Health (Imported Food) (Scotland) Regulations
1937 to 1948

FRANCE

THE Secretary of State for Scotland gives notice in pursuance of the above-named Regulations that his recognition of the Official Certificates reproduced in Part I of the Schedule to the Notice published in the Edinburgh Gazette dated 5th April, 1938, and the Schedule to the Notice published in the Edinburgh Gazette dated 28th February, 1964, for the importation of meat and meat products from France, is hereby modified to the extent shown in the Schedule hereto.



HER Majesty's Postmaster General hereby gives notice that a public phototelegraph service between the United Kingdom, the Channel Islands, and the Isle of Man on the one hand and Malaysia on the other will become available on 26th February 1968.
