Public Health (Imported Food) (Scotland) Regulations
1937 to 1948

FRANCE

THE Secretary of State for Scotland gives notice in pursuance of the above-named Regulations that his recognition of the Official Certificates reproduced in Part I of the Schedule to the Notice published in the Edinburgh Gazette dated 5th April, 1938, and the Schedule to the Notice published in the Edinburgh Gazette dated 28th February, 1964, for the importation of meat and meat products from France, is hereby modified to the extent shown in the Schedule hereto.

The notices published in the Edinburgh Gazette dated 22nd September, 1967, 27th October, 1967 and 1st December, 1967, are hereby revoked.

PHOTOTELEGRAMS

HER Majesty's Postmaster General hereby gives notice that a public phototelegraph service between the United Kingdom, the Channel Islands, and the Isle of Man on the one hand and Malaysia on the other will become available on 26th February 1968.

Her Majesty's Postmaster General further gives notice pursuant to Regulations 8(2) and 33(7) of the Telegraph (British Commonwealth and Foreign Written Telegram) Regulations, 1959, that forthwith, and until further notice the charges for phototelegrams from the United Kingdom, the Channel Islands and the Isle of Man to Malaysia will be as follows:

Her Majesty's Postmaster General Hereby gives notice in accordance with paragraphs (7) and (9) of Regulation 32 and paragraph (3) of Regulation 25 of the Telephone Regulations, 1965 that the service charge payable for the attempt to provide a Credit Card call to the United Kingdom, the Channel Islands, or the Isle of Man from the countries mentioned in Column 1 of the Schedule hereto provided shall be that set out in Column 2 of the said Schedule.

Her Majesty's Postmaster General hereby gives notice in accordance with paragraph (7) of Regulation 32 and paragraph (3) of Regulation 25 of the Telephone Regulations, 1965 that until further notice the call charges payable for a Credit Card call which is established to the United Kingdom, the Channel Islands or the Isle of Man from the countries mentioned in Column 1 of the Schedule hereto provided, shall be those set out in Column 2 of the said Schedule.
