

TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 5th July 1968, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £150,000,000.

- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent on the the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.







TRUNK ROADS ACT 1946: SPECIAL ROADS ACT 1949 HELMSDALE DIVERSION

THE Secretary of State proposes to make the following orders:

- 1. BURGH OF PAISLEY CLEAN AIR ACT, 1956

The Paisley No. 9 (Williamsburgh) Smoke Control Area Order, 1968

Subject to the exemptions provided by the Order and by virtue of Section 11(4) of the Act, if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20, unless he proves that the emission of smoke was not caused by the use of any ful other than an authorised fuel. The authorised fuels are: anthracite (including semi-anthracite), briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels, fluidised char binder-less briquettes and "Multiheat" briquettes manufactured by the National Coal Board, and low volatile steam coals.
- 3. The Order will not come into operation until at less six months after it is confirmed by the Secretary of State, and in any event not before 1st October 1971.
- 4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the office of the Chid Sanitary Inspector, at 20 Back Sneddon Street, Paisley, from 9 a.m. to 5.30 p.m. Mondays to Fridays, during the period of six weeks from the Ninth day of July 1968.
