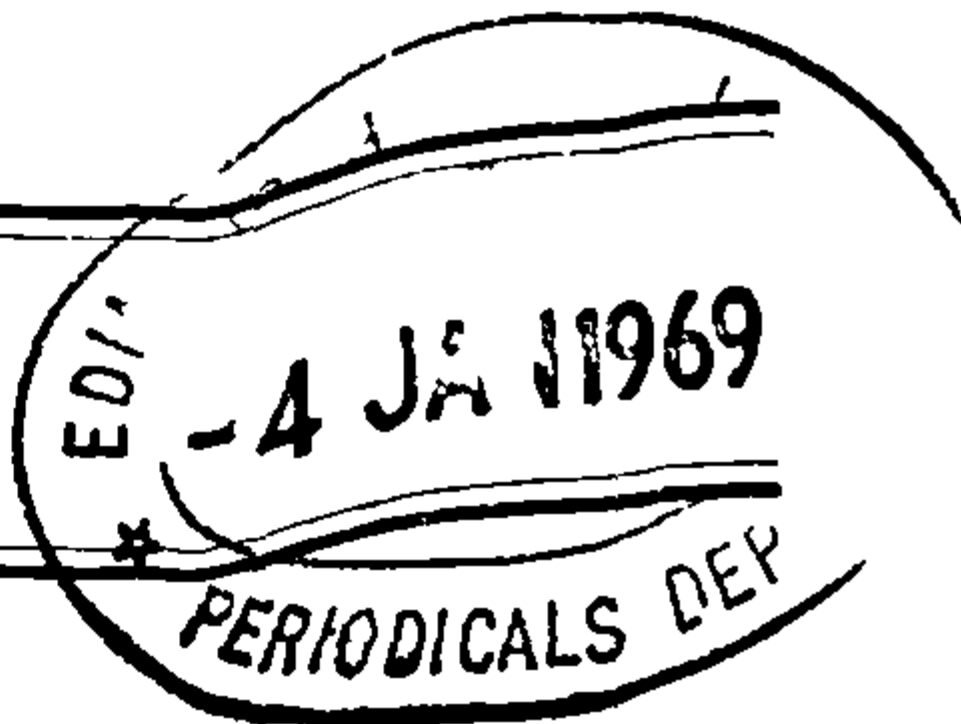

**PRICES AND INCOMES ACT 1966**  
**TOP SALARIES IN THE PRIVATE SECTOR AND NATIONALISED INDUSTRIES**

*Direction under section 5(4) further extending the period within which the National Board for Prices and Incomes must publish their report*

WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity and the Chancellor of the Exchequer, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, referred the above mentioned question to the National Board for Prices and

Incomes for examination and have published the text of the reference in the Gazette on 2nd July 1968;

2. And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;

3. And whereas the First Secretary of State and Secretary of State for Employment and Productivity and the Chancellor of the Exchequer, in pursuance of their powers under the said section 5(4), by a direction published in the Gazette on 17th September 1968 extended the said period of three months by three months.

4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity and the Chancellor of the Exchequer, in pursuance of their powers under the said section 5(4), hereby direct that the said period of three months be further extended by three months.

**PRICES AND INCOMES ACT 1966**

*Reference to the National Board for Prices and Incomes of an award relating to the salaries and job maxima of certain staff employees of the Imperial Chemical Industries Limited.*

IMPERIAL CHEMICAL INDUSTRIES LIMITED have notified a proposal to increase staff salary levels and job maxima. In justification of this proposal the Company have submitted evidence of increased productivity and a reduction in recent years of their price index.

The effect of the Order will be:—

1. To prohibit with certain exceptions, the waiting of vehicles in the following lengths of road:—

(1) TEMPLEHALL AVENUE

south side thereof from the westmost boundary of Templehall Branch Library eastwards for a distance of approximately 66 yards.

(2) TEMPLEHALL AVENUE

north side thereof from its junction with the east side of Fair Isle Road eastwards for a distance of approximately 36 yards.

(3) TEMPLEHALL AVENUE

north side thereof from its junction with the west side of Fair Isle Road westwards to a point opposite the westmost boundary of Templehall Branch Library.

(4) FAIR ISLE ROAD

east side thereof from its junction with Templehall

east side thereof from its junction with the south side of Cairnwell Place southwards for a distance of approximately 59 yards.

(10) DUNEARN DRIVE

both sides of central reservation from a point opposite the westmost boundary of Templehall Branch Library westwards and southwards to a point opposite the junction of Dunearn Drive and Cairnwell Place.

(11) DUNEARN DRIVE

north and west side thereof from a point opposite the westmost boundary of Templehall Branch Library westwards and southwards to its junction with the north side of Brodick Road (Service Road).

(12) DUNEARN DRIVE

west side thereof from its junction with the south side of Brodick Road (Service Road) southwards to its junction with the north side of Brodick Road.

(13) DUNEARN DRIVE

west side thereof from its junction with the south side of Brodick Road southwards for a distance of approximately 13 yards.

(14) CAIRNWELL PLACE

north side thereof from its junction with Dunearn Drive eastwards to its junction with the west side of the rear access road leading off Cairnwell Place and lying between numbers 60 and 62 Cairnwell Place.

west side thereof from its junction with Brodick Road northwards for a distance of approximately 54 yards.

(30) Rear access road leading off ALFORD AVENUE and lying between number 2 ALFORD AVENUE and number 12 BRODICK ROAD
