# TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 10th January 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £100,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday the 13th January 1969 to Saturday the 18th January 1969, inclusive, and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

# PRICES AND INCOMES ACT 1966

Report by the National Board for Prices and Incomes
PAY OF MAINTENANCE WORKERS EMPLOYED
BY BUS COMPANIES

ON 13th September 1968, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Transport referred to the National Board for Prices and Incomes for examination the pay of maintenance workers employed by companies represented on the National Council for the Omnibus Industry and the scope for increased productivity.

The Board has now made its report entitled "Pay of Maintenance Workers Employed by Bus Companies." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Transport hereby give notice that the report was first published as Command Paper Number 3868 on 2nd January 1969.

# DRAFT QUARRY VEHICLES REGULATIONS 1969

THE Minister of Power, in accordance with the provisions of Section 142 of and Part 1 of the Second Schedule to the Mines and Quarries Act 1954, hereby gives notice that he proposes to make General Regulations under Section 141 of the Act entitled the Quarry Vehicles Regulations 1969.

The draft regulations set out new statutory requirements concerning safety, the proper observance of which should reduce the number of accidents in quarries caused by the use of quarry vehicles. The Regulations will apply to mechanically propelled vehicles which form part of the equipment of the quarry but exclude ropeway vehicles and vehicles used on rails, which are the subject of the Quarries (Ropeways and Vehicles) Regulations 1958, and motor cycles, and pedestrian controlled vehicles.

The draft regulations require the provision of adequate audible warning instruments, artificial lighting in the hours of darkness, safety devices for use with vehicles that have tipping bodies, warning notices of overhead obstructions and traffic signs where necessary. They also deal with the appointment of drivers and their conduct and require managers to make rules for regulating the conduct of persons using such vehicles for the purpose of securing compliance with the regulations.

Road Traffic Regulation Act, 1967

The City of Dundee (City Square) (Restriction of Waiting) Order, 1969

THE Corporation of the City of Dundee propose to make an Order under Sections 1 and 2 of the Road Traffic Regulation Act, 1967, the effect of which is set out in the Schedule hereto.

#### SCHEDULE

The effect of the proposed Order is as follows. viz.:

- I. To prohibit (subject to certain exceptions\*) the waiting of vehicles at all times in any of the following lengths of road, viz.:
  - 1. CITY SQUARE (North-east carriageway).
    - (a) On the North-east side thereof for a distance of 19' 6" or thereby south-eastwards from its junction with High Street; and
    - (b) On the South-west side thereof for a distance of 19' 6" or thereby south-eastwards from its junction with High Street.
  - 2. CITY SQUARE (South-west carriageway).
    - (a) On the North-east side thereof for a distance of 15' or thereby south-eastwards from its junction with High Street; and
    - (b) On the South-west side thereof for a distance of 15' or thereby south-eastwards from its junction with High Street.
- II. To prohibit (subject to certain exceptions\*) the waiting of vehicles at any time between the hours of 8 a.m. and 6.30 p.m. in the following length of road, viz.:

# CITY SQUARE (North-east carriageway)

On the North-east side thereof from a point 19' 6" or thereby south-eastwards from its junction with High Street to a point 109' 6" or thereby south-eastwards from said junction.

III. To prohibit (subject to certain exceptions\*) the waiting of vehicles between 8 a.m. and 6.30 p.m. for a period longer than forty-five minutes in any period of two hours in any of the following lengths of road, viz.:

CITY SQUARE (North-east carriageway).

- (a) On the North-east side thereof from a point 109' 6" or thereby south-eastwards from its junction with High Street to a point 189' 6" south-eastwards from said junction; and
- (b) On the South-west side thereof from a point 19' 6" or thereby south-eastwards from its junction with High Street to a point 169' 6" or thereby from said junction.

# \*Notes.

- 1. The proposed Order will not apply on Sundays.
- 2. The proposed Order will not prohibit the waiting of vehicles for any of the following purposes:
  - (a) building operations or operations relating to the maintenance, improvement or repair of sewers, pipes or apparatus for the supply of gas, water or electricity or telegraphic lines, etc.,
  - (b) police, fire, ambulance or other statutory purposes,
  - (c) collection or delivery of postal packets (by G.P.O. vehicles),
  - (d) funeral undertaking,
  - (e) loading, unloading, collection or delivery of goods, subject to a maximum waiting period of 30 minutes in any one place,
  - (f) hackney carriages waiting upon a duly authorised cab rank,
  - (g) the removal of furniture.
- 3. The proposed Order contains provision for the granting of exemptions to severely disabled drivers.
