TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday the 17th January 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £100,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday the 20th January 1969 to Saturday the 25th January 1969, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. (Saturday 11 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

FISHERY BYELAW FOR FIRTH OF CLYDE

NOTICE Is Hereby Given that the following byelaw has been made and confirmed by the Secretary of State for Scotland:

SEA FISHERIES

The Sea Fisheries (Scotland) Byelaw (No. 84) 1968

Made 8th November 1968

Coming into Operation 9th January 1969

The Secretary of State in exercise of the powers conferred on him by section 4 of the Sea Fisheries (Scotland) Amendment Act 1885 (a) and of all other powers enabling him in that behalf hereby makes the following Byelaw:

Citation, commencement and interpretation

1.—(1) This Byelaw may be cited as the Sea Fisheries (Scotland) Byelaw (No. 84) 1968.

(2) This Byelaw shall come into operation on the date of its confirmation by the Secretary of State.

(3) The Interpretation Act 1889 (b) shall apply for the interpretation of this Byelaw as it applies for the interpretation of an Act of Parliament.

Prohibition of Method of fishing in a defined area of the Firth of Clyde

2. Except as hereinafter provided it shall not be lawful for any person to use the method of fishing known as pair trawling within that area of the Firth of Clyde lying south-

wards of a line drawn 270 degrees true from Bennane Head in the County of Ayr and eastwards of a line drawn 360 degrees true from Milleur Point in the County of Wigtown during the whole or any part of the period from 1st February to 31st March in any year occurring within the space of three years from the date of coming into operation of this Byelaw.

Provided that nothing in this Byelaw shall apply in relation to the use of the said method of fishing within that area by a person in the service of or possessing the written authority of the Secretary of State.

TRUNK ROADS ACT, 1946 BANAVIE BRIDGE
