Stirling County Development Plan

*The County of Stirling Development Plan Amendment
(Maddiston) Order, 1968*

NOTICE Is Hereby Given that on the Seventeenth day of January Nineteen Hundred and Sixty-nine, the Secretary of State for Scotland approved, without modification the alteration of the County Development Plan relating to the zoning of 3.2 acres of land at Maddiston for Public Open Space and to designate 1.24 acres of this area for compulsory acquisition.

A certified copy of the extract of the Development Plan as altered by the Secretary of State has been deposited at the offices of the County Planning Department, Old High School, Stirling; the County Offices, Viewforth, Stirling and the Sanitary Inspector's Office, County Offices, West Bridge Street, Falkirk.

Each extract of the altered Development Plan so deposited is available for inspection by the public, free of charge, between the hours of 9 a.m. and 1 p.m. and 2 p.m. and 5 p.m. on Mondays to Fridays inclusive each week for a period of six weeks from the date of publication of this notice.

The alteration to the Development Plan becomes operative as from Twenty-fourth January Nineteen Hundred and Sixty-nine, but if any person aggrieved by the alteration desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning (Scotland) Act, 1947, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the making of the alteration he may, within six weeks from the Twenty-fourth day of January Nineteen Hundred and Sixty-nine, make application to the Court of Session.

BURGH OF BO'NESS

Road Traffic Regulation Act, 1967

*The Burgh of Bo'ness (Cadzow Lane) (Prohibition of Use)
Order 1968*

ON the Thirteenth day of January Nineteen Hundred and Sixty-nine the Secretary of State confirmed the Burgh of Bo'ness (Cadzow Lane) (Prohibition of Use) Order 1968 made by the Town Council of the Burgh of Bo'ness under the Road Traffic Regulation Act 1967, the effect of which is set out in the Schedule hereto.

SCHEDULE

The effect of the said Order will be to prohibit the use of Cadzow Lane, Bo'ness by vehicular traffic with the exception of vehicles being used—

- (a) for the conveyance of persons, goods, etc. to or from any premises situated on or adjacent to Cadzow Lane and
- (b) in connection with any building operations, etc. in or adjacent to Cadzow Lane.

EDINBURGH CORPORATION

*The Edinburgh Corporation (Box Functions)
Traffic Order, 1969*

ON 16th January 1969 Edinburgh Corporation made an Order under sections 1 and 2 of the Road Traffic Regulation Act, 1967 which will come into operation on the 17th day of March 1969, the effect of which is to prohibit (subject to certain exceptions) any person from driving a vehicle into a "boxed area" and thereafter driving it in such a direction that it becomes necessary, owing to the presence of stationary vehicles, for any part of the vehicle to remain at rest within the "boxed area."

A "boxed area" as referred to in the preceding paragraph will be provided at each of the road junctions described in the schedule hereto which will be marked by traffic signs consisting of hatched yellow lines painted on the carriageway.
