The effect of the order is to impose the following amended restrictions on the trunk road (route A.7) High Street, Bridge Place and Bank Street, Galashiels:

- 1. No waiting at any time:
  - (a) on the south-east side of Bridge Place from High Street to Bridge Street;
  - (b) on the north-west side of Bridge Place from Island Street for 40 yards in a north-easterly direction;
  - (c) on the north-east side of High Street from Bridge Place in a south-easterly direction for 158 yards;
  - (d) on the south-west side of High Street from Roxburgh Street in a south-easterly direction for 288 yards;
  - (e) on the north and east side of High Street and the north-east side of Bank Street from 10 yards northwest of Sime Place to 17 yards south-east of Overhaugh Street;
  - on the south-west side of Bank Street from High Street to St. John Street;
  - on the west side of the fountain in Cornmill Square opposite St. John's Church for a distance of 29 yards.

- 2. Waiting limited to 30 minutes in any hour between the hours of 8 a.m. and 6 p.m.
  - (a) on the north-east side of High Street from 158 yards south-east of Bridge Place to 10 yards north-west of Sime Place;
  - (b) on the west side of High Street, from Bank Street for 28 yards in a northerly direction;
  - (c) on the north-east side of Bank Street, from 17 yards south-east of Overhaugh Street to a point opposite the south kerbline of St. John Street.

The Order provides for exceptions to enable a vehicle to wait for as long as necessary for a person to board or alight, to enable goods to be loaded or unloaded and to be used in connection with the maintenance operations and other works.
