THE First Secretary and Secretary of State for Employment and Productivity hereby gives notice that on 13th May 1969 she made the Asbestos Regulations 1969. The regulations impose requirements for the safety and welfare of persons employed in factories and other places to which the Factories Act 1961 applies where processes involving asbestos or articles composed wholly or partly of asbestos and capable of giving rise to asbestos dust are carried on. The regulations require that the processes be carried on under an exhaust draught or in some other equally safe way, or that protective clothing and respiratory protective equipment be provided for the use of persons employed. The regulations also impose requirements as to the cleaning of premises and plant, the construction of buildings newly used for the processes, the storage and distribution of asbestos, the accommodation to be provided for protective equipment and the cleaning of protective clothing. The employment of young persons in connection with processes to which the regulations apply is prohibited except in specified circumstances. The regulations also require that notification of processes involving crocidolite be sent to the inspector for the district. The regulations will come into force on 14th May 1970.

The Asbestos Industry Regulations 1931 are revoked by the regulations and certain provisions relating to asbestos in the Shipbuilding and Shiprepairing Regulations 1960 are also revoked.

PRICES AND INCOMES ACT 1966

Report by the National Board for Prices and Incomes

STEEL PRICES

ON 24th December 1968, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Power referred to the National Board for Prices and Incomes for examination the British Steel Corporation's proposals for a new price structure, and new price levels, for iron and steel products produced by the nationalised steel industry. The Board has now made its report entitled "Steel Prices." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Power hereby give notice that the report was first published as Command Paper Number 4033 on 21st May 1969.

PRICES AND INCOMES ACT 1966

Reference to the National Board for Prices and Incomes

COAL PRICES

1. THE National Coal Board has consulted the Minister of Power about price proposals affecting industrial coal produced in the East Midlands and domestic solid fuels, which would increase their revenue by about £15 million annually.

2. In pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity, and the Minister of Power hereby refer these proposals to the National Board for Prices and Incomes for examination against the background of the Government's policies for the nationalised industries.

PRODUCTIVITY AGREEMENTS

Direction under section 5(4) further extending the period within which the National Board for Prices and Incomes must publish their report

WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and has published the text of the reference in the Gazette on 26th November 1968;

2. And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;

3. And whereas, in pursuance of her powers under the said section 5(4), the First Secretary of State and Secretary of State for Employment and Productivity, by a direction published in the Gazette on 25th February 1969, extended the said period of three months by three months;

4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said section 5(4), hereby directs that the said period of three months be further extended by two months.

EDINBURGH
