## PRICES AND INCOMES ACT 1966

### *Report by The National Board for Prices and Incomes* MANUFACTURERS' PRICES OF TOILET PREPARATIONS

ON 24th December 1968, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade referred to the National Board for Prices and Incomes for examination the question of manufacturers' prices in the toilet preparations industry. The Board has now made its report entitled "Manufacturers' Prices of Toilet Preparations." In accordance with section 5(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade hereby give notice that the report was first published as Command Paper Number 4066 on 3rd June 1969.

## PRICES AND INCOMES ACT 1966

### PRICES OF NON-ALLOY BRIGHT STEEL BARS *Direction under section 5(4) extending the period within which the National Board for Prices and Incomes must publish their report*

WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Power, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 7th March 1969.

### *Report by The National Board for Prices and Incomes* PAY AND DUTIES OF LIGHT-KEEPERS

ON 28th February 1969, in pursuance of their powers under Section (1) of the Prices and Incomes Act 1966 the First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade referred to the National Board for Prices and Incomes for examination the question of pay and duties of light-keepers employed by Trinity House and the Northern Lighthouse Board with particular relation to hours worked. The Board has now made its report entitled "Pay and Duties of Light-Keepers."

## PRICES AND INCOMES ACT 1966

### *Reference to The National Board for Prices and Incomes* PAY OF PILOTS EMPLOYED BY THE BRITISH OVERSEAS AIRWAYS CORPORATION

ON 5th April 1969 an agreement was reached between British Overseas Airways Corporation and the British Air Line Pilots' Association on the pay of pilots employed by the Corporation. The agreement provided *inter alia* for a minimum guarantee to operate from 1st April 1969 and a bid-line system of pay to be introduced by 31st October 1969. The provision for a minimum guarantee has been implemented from 1st April 1969 and the rules of the bid-line system have still to be determined by the parties.

The First Secretary of State and Secretary of State for Employment and Productivity and the Board of Trade acting jointly in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, hereby refer to the National Board for Prices and Incomes for examination and report:

(a) the question of the productivity implications of the agreement reached between British Overseas Airways

- Corporation and the British Air Line Pilots' Association on 5th April and the extent to which increased productivity and savings will offset increased costs ;

(b) the implications of the agreement for future negotiations between the Corporation and the Association with particular reference to a reduction in the number of pilots in certain aircraft crews from three to two and the pay and conditions of employment of pilots who are to fly the Boeing 747.
