TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 20th June 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £140,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 23rd June 1969, to Friday, the 27th June 1969, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PRICES AND INCOMES ACT

Report by the National Board for Prices and Incomes

PAY OF THE ARMED FORCES

be lawful for the said David Brown to give prescriptions prescribing any substance for the time being falling within Part I of the Schedule to the Dangerous Drugs Act 1965.

1. No person shall drive or cause or permit to be driven any vehicle on any of the following lengths of road otherwise than in the direction shown:
 - (a) West Maitland Street (between the junction with Haymarket and a point 120 feet or thereby north-east of the centre line of Palmerston Place) from West to East.
 - (b) Torphichen Street (whole street) from West to East.
 - (c) Torphichen Place (whole street) from North to South.
 - (d) Dewar Place (whole street) from North to South.
 - (e) Morrison Street (between the junction with Dewar Place and its junction with Haymarket) from East to West.
 - (f) Lansdowne Crescent (between its junction with Palmerston Place and the junction with Grosvenor Street) from East to West.
 - (g) Haymarket (North of the West Central Island from the junction with Glasgow Road (City Section) to its junction with West Maitland Street) from West to East.
 - (h) Haymarket (East of the East Central Island from its junction with Morrison Street to its junction with West Maitland Street) from South to North.
 - (i) Haymarket (South of the East Central Island from its junction with Morrison Street to the line of the projected centre line of Dalry Road) from East to West.
 - (j) Glasgow Road (North of the West Central Island from the West end of the Island to its junction with Haymarket) from West to East.
2. No person shall drive or cause or permit to be driven any vehicle so as to make a right-hand turn from:
 - (a) Gardner's Crescent into Morrison Street.
 - (b) West Maitland Street immediately east of Palmerston Place into Torphichen Street.
 - (c) Haymarket South of the East Central Island into Haymarket West of the East Central Island.
 - (d) Haymarket North of the West Central Island into Haymarket East of the West Central Island.
3. No person shall drive or cause or permit to be driven any vehicle so that it shall enter Lansdowne Crescent (West of its junction with Grosvenor Street) from Lansdowne Crescent (East of its junction with Grosvenor Street).
4. No person shall drive or cause or permit to be driven any vehicle between the hours of 8.15 a.m. and 9.15 a.m. and 4.30 p.m. and 6 p.m. on Mondays to Fridays inclusive so as to make a right-hand turn from
 - (a) West Maitland Street into Manor Place.
 - (b) Manor Place into West Maitland Street.
5. Save as otherwise provided for in this schedule no person shall except upon the direction or with the permission of a Police Constable in uniform cause or permit any vehicle to wait between the hours of 8.15 a.m. and 6 p.m. on Mondays to Fridays inclusive and between 8.15 a.m. and 1.30 p.m. on Saturdays, any such day not being a public holiday, in any of the following lengths of road:
 - (a) Glasgow Road (Haymarket Terrace) Eastwards from a point in Glasgow Road immediately east of its junction with Devon Place continuously to its junction with Haymarket.
 - (b) Haymarket Eastwards from its junction with Glasgow Road to its junction with West Maitland Street, Dalry Road and Morrison Street.
 - (c) West Maitland Street Eastwards from its junction with Haymarket continuously to its junction with Shandwick Place.
 - (d) Shandwick Place Eastwards from its junction with West Maitland Street continuously to a point immediately east of its junction with Canning Street.
 - (e) Torphichen Street Eastwards from its junction with West Maitland Street continuously to its junction with Dewar Place.
 - (f) Dewar Place Southwards from its junction with Torphichen Street continuously to its junction with Morrison Street.
 - (g) Morrison Street Westwards from a point immediately east of its junction with Gardner's Crescent continuously to its junction with Haymarket with the exception of that part of the North Side of Morrison Street extending from a point 19 yards or thereby west of the projected line of the western kerblines in Dewar Place westwards for a distance of 46 yards or thereby and from a point 83 yards or thereby west of the projected western kerblines in Dewar Place westwards for a distance of 40 yards or thereby from a point 139 yards or thereby west of the projected western kerblines of Dewar Place westwards for a distance of 45 yards or thereby.

East Side Southwards from the projected line of south kerblines of Morrison Street, for a distance of 20 yards or thereby.

West Side Southwards from the projected line of the south kerblines of Morrison Street for a distance of 30 yards or thereby.
 - (n) Grove Street

West Side Southwards from the projected line of the south kerblines of Morrison Street for a distance of 15 yards or thereby.

East Side Southwards from the projected line of the south kerblines of Morrison Street for a distance of 12 yards or thereby.
 - (o) Magdala Crescent Northwards from its junction with Glasgow Road for a distance of 20 yards or thereby.
 - (p) Coates Gardens Northwards from its junction with Glasgow Road for a distance of 20 yards or thereby.
 - (q) Rosebery Crescent Northwards from its junction with Glasgow Road for a distance of 20 yards or thereby.
 - (r) Coates Crescent

South Junction with Shandwick Place

West Side Northwards from the projected line of the north kerblines of Shandwick Place for a distance of 30 yards or thereby.

East Side Northwards from the projected line of the north kerblines of Shandwick Place for a distance of 10 yards or thereby.
