Report by the National Board for Prices and Incomes

A settlement and certain proposals relating to the pay of workers employed in the EXHIBITION INDUSTRY.

ON 18th March 1969, in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity referred to the National Board for Prices and Incomes for their examination and report:

- (1) the settlement reached on 7th February 1969 by the National Joint Council for the Exhibition Industry providing, amongst other things, for—
 - (a) increases in the hourly rates of wages of craftsmen and labourers of fourpence and threepence respectively; and
 - (b) a productivity bonus of ten shillings per day (including week-end working) for all operatives covered by the said National Joint Council employed in shops and exhibition halls; and
- (2) the proposals made on 28th February 1969 by the

1.
