A PROCLAMATION

CALLING IN ALL HALFPENNIES

ELIZABETH R.

Whereas under section 11 of the Coinage Act 1870 We have power, with the advice of Our Privy Council, by Proclamation to call in coins of any date or denomination:

And Whereas it now appears to Us desirable to call in all halfpennies:

We, therefore, with the advice of Our Privy Council and in pursuance of section 11 of the Coinage Act 1870, do hereby call in by the thirty-first day of July One thousand nine hundred and sixty-nine all halfpennies, and direct that after such thirty-first day of July One thousand nine hundred and sixty-nine such coins shall not be current or legal tender within Our United Kingdom of Great Britain and Northern Ireland.

Given at Our Court at Buckingham Palace, this twenty-fifth day of June, in the year of our Lord One thousand nine hundred and sixty-nine, and in the eighteenth year of Our Reign.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 3(6) and 13 of the Import Duties Act 1958

Viz.: The Import Duties (Temporary Exemptions) (No. 4) Order, 1969.

This Order provides that the goods listed in Schedule 1 shall be temporarily exempt from import duty, and those listed in Schedule 2 shall continue to be exempt from import duty, both until 1st January 1970, except for items for which an earlier day is specified.

The Order determines the amount of the fees payable by occupiers of factories to appointed factory doctors (unless otherwise agreed between them) for medical examinations (other than certain special examinations) under the Ionising Radiations (Sealed Sources) Regulations 1969.

FACTORIES ACT 1961

Ionising Radiations (Sealed Sources) Regulations 1969

THE First Secretary of State and Secretary of State for Employment and Productivity hereby gives notice that on 12th June 1969 she made the Ionising Radiations (Sealed Sources) Regulations 1969. The Regulations impose requirements to afford protection against the risk of bodily injury to persons working in premises and places to which the Factories Act 1961 applies against ionising radiations arising from sealed sources, any machine or apparatus intended to produce ionising radiations or any machine or apparatus (being a machine or apparatus which emits ionising radiations) in which charged particles are accelerated by a voltage of not less than five kilovolts. The Regulations revoke and replace the Ionising Radiations (Sealed Sources) Regulations 1961.

The requirements as to the marking of radiation area boundaries, as to sealed sources used in gauges, etc., and as to machines and apparatus used in gauges, monitors, etc., come into operation six months after the making of the Regulations. The remainder of the Regulations come into operation after one month.

PRICES AND INCOMES ACTS 1966 to 1968

THE Secretary of State hereby gives notice of a proposal to make an Order under section 1(2) (b) of the Prices and Incomes Act 1967, as amended by section 3(2) of the Prices and Incomes Act 1968, in the terms set out at the end of this notice. The effect of this Order will be to continue until 17th February 1970 the standstill on the implementation of the undermentioned settlement which was applied under section 15(2) of the Prices and Incomes Act 1966 by virtue of a reference to the National Board for Prices and Incomes under section 2 of that Act made on 18th March 1969, that is to say—

the settlement reached on 7th February 1969 by the National Joint Council for the Exhibition Industry providing, amongst other things, for—

- (a) increases in the hourly rate of wages of craftsmen and labourers of 4d. and 3d. respectively; and
- (b) a productivity bonus of 10s. per day (including week and working) for all operatives covered by the said National Joint Council employed in shops and exhibition halls.

The standstill referred to was continued under subsection (1) and (2)(a) of section 1 of the said Act of 1967 by virtue of a recommendation of the Board adverse to the said implementation contained in their Report on the said reference published on 18th June 1969.

Representations about the proposal may be made by or on behalf of employers or employees affected by the said agreement, or by or on behalf of any employers' organisation, trade union or trade union organisation directly or indirectly representing employers or employees so affected, to the Secretary of State in writing addressed to the Department of Employment and Productivity, 8 St. James's Square, London S.W.1, not later than 11th July 1969.

After that date, and subject to the consideration of any representations duly made, the proposed Order may be made in the following terms:

Whereas by virtue of a Reference to the National Board for Prices and Incomes under section 2(1) of the Prices and Incomes Act 1966 (1966 c.33) (the text whereof was publised on 18th March 1969 in both the London and Edinburgh Gazettes) the implementation of the settlement described in Article 2 hereof relating to the pay of workers in the exhibition industry was forbidden by section 15(2) of that Act;

And whereas before the said implementation ceased to be so forbidden a Report of the Board on the said reference was published on 18th June 1969 (Report No. 117 entitled 'Pay and conditions of workers in the Exhibition Contracting Industry' (Cmnd. 4088)) with a recommendation adverse to the implementation of the said settlement;

And whereas by virtue of the said recommendation and subsection 1(1) and (2) (a) of section 1 of the Prices and Incomes Act 1967 (1967 c.53) the said section 15(2) continued to apply to the implementation of the said settlement as it applied up to the date of publication of the said Report:

Now, therefore, the Secretary of State, having given notice under section 1(2) (a) of the said Act of 1967 within a period of ten days after the date of the said publication, of a proposal to make this Order, and having taken into consideration representations duly made in pursuance of the said notice, in exercise of the powers conferred on her by section 1(2) (b) of the said Act of 1967, as amended by section 3(2) of the Prices and Incomes Act 1968 (1968 c.42), and of all other powers enabling her in that behalf, hereby makes the following Order:
