#### PRODUCTIVITY AGREEMENTS

ON 26th November 1968, in pursuance of her powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity referred to the National Board for Prices and Incomes for examination the relationship of improvements in productivity to pay structures, the implications of productivity bargaining for costs, prices and profits, and the evaluation of productivity agreements with particular reference to:

- (ii) the application of productivity measurement and agreements to clerical and other non-manual work,





#### ROYAL BURGH OF AYR

The East Park Road (East/West Leg), Tweed Street and Teviot Street Traffic Restriction Order, 1969

- 1. ON the 1st day of August 1969 the Town Council of the Royal Burgh of Ayr made an order under Sections 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968.

## ROYAL BURGH OF AYR CIVIC AMENITIES ACT, 1969 Designation of Area Number 4—Sandgate

NOTICE Is Hereby Given that in terms of Section 1 of the Civic Amenities Act. 1967, the Royal Burgh of Ayr as Local Planning Authority have designated a further Conservation Area within the Royal Burgh of Ayr as follows:
