#### TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 15th August 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act 1968, to the amount of £100,000,000.

Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent, (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

# PROPOSED TEMPORARY CLOSURE OF THE M90 FROM DULOCH T MASTERTON IN FIFE

#### TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949

Bridgend Diversion

THE Secretary of State gives notice that he proposes to make Orders under section 1 of the Trunk Roads Act 1946 and section 14 of the Special Roads Act 1949, both as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, the effect of which will be that:

- 1. A diversion which he proposes to construct at Bridgend in the County of Argyll will become a trunk road on the date when the Order comes into operation and the length of trunk road to be superseded thereby will cease to be a trunk road on 16th May next, after the date on which notice is given by the Secretary of State to Argyll County Council (who will thereafter become the Highway Authority responsible for that length) that the said diversion is open to through traffic.
- 2. A length of the existing Trunk Road will be stopped up and a length of new road will be constructed to improve access from Bridgend to the new trunk road when the diversion is opened to through traffic.
