#### TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, 22nd August 1969, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £140,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 25th August 1969, to Friday, 29th August 1969, inclusive, and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

#### Notes:

- 1. The folowing diseases were eradicated from Great Britain in the years indicated: Cattle plague or rinder-pest (pestis-bovina), 1877; epizootic lymphangitis (lymphangitis epizootica), 1906; glanders (including farcy) (malleus), 1928; parasitic mange (psoroptes et sarcoptes scabiei equi), 1948; pleuro-pneumonia (peripneumonia contagiosa bovum), 1898; rabies, 1922; sheep pox (variola ovium) 1866; and s heep scab (scabies ovium), 1952. Dourine (exanthema coitale paralyticum) has never existed in Great Britain.
- 2. The last confirmed case of swine fever was in June 1966 and the disease is now regarded as eradicated from Great Britain.
- 3. One bovine animal was slaughtered as "affected" animal within the meaning of Article 3 of the Tuberculosis Order 1964, during the period 1st April to 30th June 1969. There was another bovine animal slaughtered during the period 1st January to 31st March 1968 which has just been brought to notice.

## PROHIBITION OF WAITING ON PARK ROAD, AUCHINLECK

- 1. AYR County Council propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968.
- 2. When this Order comes into effect vehicles must not be left at any time on that length of Park Road, Auchinleck extending westwards from its junction with Main Street (Trunk Road A.76) the distance of 106 yards, or thereby.
- 3. Exceptions will permit waiting (a) for the purposes of taking up or setting down passengers, the loading or unloading of goods, where necessary in connection with the maintenance of the road, and the supply or repair of gas, electricity, water and telegraph apparatus; and (b) by disabled drivers.
