And whereas, in pursuance of her powers under the said section 5(4), the First Secretary of State and Secretary of State for Employment and Productivity, by a direction published in the Gazette on 24th October 1968, extended the said period of three months by six months, and by a direction published in the Gazette on 22nd April 1969, further extended the said period of three months by three months, and by a direction published in the Gazette on 11th July 1969, further extended the said period of three months by five weeks;
- 4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of her powers under the said section 5(4), hereby directs that the said period of three months be further extended by three months.

COAL PRICES

STOPPING UP OF HIGHWAYS IN THE CITY OF EDINBURGH

THE Secretary of State for Scotland hereby gives notice that he has made an Order under section 46 of the Town and Country Planning (Scotland) Act 1947, as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, authorising the stopping up of the entire length of Porterfield Road in the City of Edinburgh. PROPOSED TEMPORARY CLOSURE OF THE M90 FROM DULOCH TO MASTERTON IN FIFE

THE Secretary of State gives notice that he has made an order temporarily closing the southbound carriageway of the motorway M90 from the junction of the A90/B981 at
