# PRICES AND INCOMES ACT 1966 BEER PRICES

Direction under Section 5(4) further Extending the Period within which the National Board for Prices and Incomes must Publish their Report

WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Agriculture, Fisheries and Food in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and have published the text of the reference in the Gazette on 24th April 1969.

- 2. And whereas by section 5(3) of the Act, but subject to section 5(4), the Board are required to make their report so as to allow publication within three months of the said date;
- 3. And whereas the First Secretary of State and Secretary of State for Employment and Productivity, and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under the said section 5(4), by a direction published in the Gazette on 24th July 1969 extended the said period of three months by three months, and by a direction published in the Gazette on 24th October 1969 further extended the said period of three months by one month;
- 4. Now, therefore, the First Secretary of State and Secretary of State for Employment and Productivity, and the Minister of Agriculture, Fisheries and Food, in pursuance of their powers under the said section 5(4), hereby direct that the said period of three months be further extended by two weeks.

#### RELATIVE TO PROBATION ORDERS

Proposed Experimental One-Way Traffic System and Waiting Restrictions—

#### TRUNK ROAD A.96 IN HUNTLY

THE Secretary of State proposes to make an experimental order imposing a one-way traffic system and prohibiting waiting on lengths of the Trunk Road A.96 in Huntly.

Vehicles would have to proceed in one direction only, from West to East on Deveron Street, Duke Street and Bogie Street to its junction with New Road.

Waiting would be prohibited at any time on parts of Deveron Street, Duke Street, and Bogie Street, from the junction with King Street and Meadow Street in the West to Bogie Bridge in the east.

Exceptions would permit waiting, for the purposes of:

- a. picking up and setting down passengers,
- b. loading and unloading goods and where necessary, in connection with:
- c. the maintenance of the roads,
- d. the supply of gas, electricity and water, and
- e. disabled drivers.

The recommended route for west bound traffic is via Gladstone Road, Bleachfield Street, Market Street and King Street.
