

This Order revokes the fixed rate of drawback of import duty in respect of exported pigment produced or manufactured from imported cadmium metal. The effect is that drawback will in future be related to the duty paid in respect of the quantity of imported cadmium metal used in the manufacture of the particular pigment exported.

This Order comes into operation on 5th February, 1970, and has been published as Statutory Instruments 1970 No. 95.

Direction under section 5(4) further extending the period within which the National Board for Prices and Incomes must publish their report.

1.
