- 3. To porhibit (subject to certain exceptions\*) the waiting of vehicles between 8 a.m. and 6 p.m. in any day for a period longer than 10 minutes in any one hour in any of the following lengths of road:
  - 1. High Street (part) (East side).
  - 2. Swan Street (part) (South side).
- 4. To prohibit vehicles proceeding otherwise than Southerly in any of the following lengths of road:
  - 1. High Street between its junction with St. David Street and Swan Street and its junction with Cross Keys Close.
  - 2. City Road between its junction with Swan Street and St. James' Place and its junction with Cross Keys Close.
- 5. To repeal the provisions of The Brechin (Unilateral Waiting and One-Way) Order, 1966.
- \* The proposed Order will not prohibit the waiting of vehicles for any of the following purposes:
- (a) Building operations or operations relating to the repair, maintenance or improvement of sewers, pipes or apparatus for the supply of gas, electricity or water or telegraphic lines, etc.
- (b) Goods to be loaded or unloaded from a vehicle.
- (c) A person to board or alight from a vehicle.

The County of Fife (Kennoway—Various Streets Waiting Restrictions) Experimental Traffic Regulation Order, 1970
