### TENDERS FOR TREASURY BILLS

1. ## THE TRUNK ROADS (HIGH STREET, AUCHTERARDER)

(Prohibition of Waiting and Loading) Order 1968

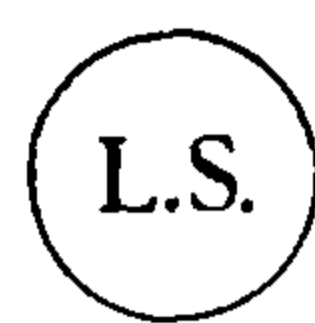

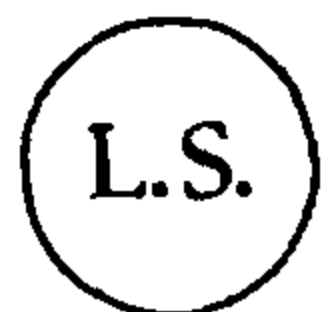
