PRICES AND INCOMÉS ACT 1966 OVERTIME AND SHIFT WORKING

Direction under Section 5(4) further extending the period within which the National Board for Prices and Incomes must publish their Report.

- 1. WHEREAS the First Secretary of State and Secretary of State for Employment and Productivity, in pursuance of his powers under Section 2(1) of the Prices and Incomes Act 1966, referred the above-mentioned question to the National Board for Prices and Incomes for examination and has published the text of the reference in the gazette on 29th April 1969.

said period of three months by six months, and by a direction published in the gazette on 29th January 1970, further extended the said period of three months by six months.

4. Now, therefore, the Secretary of State for Employment and Productivity. in pursuance of his powers under the said Section 5(4) hereby directs that the said period of three months be further extended by three months.

The effect of the Order is to revoke the Market Square Prohibition of Waiting Order 1966 and the High Street prohibition of Waiting Order 1966 and to provide that subject to certain exceptions vehicles may not now be parked at all on the greater part of the High Street south side (A.6091) and between the hours of 10 a.m. and 6 p.m. for periods in excess of 30 minutes on the whole length of the High Street (north side).
- 3. Exceptions in certain lengths of the road will permit waiting for the purpose of:—
 - (a) picking up and setting down passengers,
 - (b) loading or unloading goods, and where necessary, in connection with:
 - (c) the maintenance of the roads, and
 - (d) the supply of gas, electricity and water.
