A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE 16TH DAY OF JULY
1970, DECLARING THE EXISTENCE OF A STATE OF EMERGENCY

ELIZABETH R.

Whereas by Our Proclamation, dated the sixteenth day of July, nineteen hundred and seventy, We declare that a state of emergency existed within the meaning of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964:

And whereas it appears to Us that the state of emergency has now ceased to exist and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We do, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked.

Given at Our Court at Buckingham Palace this fourth day of August, in the year of our Lord nineteen hundred and seventy, and in the nineteenth year of Our Reign.

CLEAN AIR ACT ACT 1956

THE BURGH OF FALKIRK

Smoke Control Area Order (No. 9), 1970

1. NOTICE is hereby given that the Provost, Magistrates and Councillors of the Burgh of Falkirk in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the 25th day of May, 1970, made an Order entitled The Burgh of Falkirk Smoke Control Area Order (No. 9), 1970, declaring the area described in the Schedule hereto to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for Scotland for confirmation.

2. Subject to the exemptions provided by the Order and shown in the schedule hereto and by virtue of Section 11(4) of the Act if, on any day after the Order has come into operation smoke is emitted from a chimney of any building within the Smoke Control Area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels are: anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals, fluidised char binderless briquettes manufactured by the National Coal Board and "Multiheat" briquettes having anthracite as a main constituent which have been subjected to a mild heat treatment process, and manufacture by the National Coal Board.

3. The Order will come into operation on the First day of May 1971 or on such later date as is not earlier than six months from the date of the confirmation of the Order by the Secretary of State for Scotland.

4. Copies of the Order and of the Map referred to therein may be inspected free of charge at the Town Clerk's Office, Municipal Buildings, Falkirk at all reasonable times during the period of six weeks from the 8th day of August, 1970.

5. Within the said period any person who may be affected by the Order may by notice in writing to the Secretary, Scottish Development Department, St. Andrew's House, Edinburgh, object to the confirmation of the Order.

6. In order to qualify for grant for adaptation of a fire-place, expenditure must be incurred to the satisfaction of the said Burgh either (i) by the owner or the occupier or other interested person after confirmation of the Order with the approval of the said Burgh, and incurred before the Order comes into operation or (ii) by the owner or occupier required by a notice under Section 12(2) of the said Act served at any time after confirmation of the Order.

The area is in the Burgh of Falkirk and consists of 200 acres or thereby, and is bounded as follows:—

On the South by the Forth and Clyde Canal from the Eastern boundary of the Camelon Juniors Football Ground, to the Grahamston-Glasgow Railway at the Swing Bridge over the Forth and Clyde Canal Road.
