

Whereas the Secretary of State for Scotland has, in pursuance of the powers competent to him under the Burial Grounds (Scotland) Act 1855(c.68), made a Representation that he has received a copy of an Extract Decree dated the 19th day of February 1970 pronounced by the Sheriff Substitute of Perth and Angus at Perth, finding that the Burial Ground known as Moulin Churchyard in the Burgh of Pitlochry and County of Perth is in a condition which is dangerous to health and is overcrowded:

And Whereas in the said Representation it is recommended that in terms of section 5 of the said Act burials be discontinued forthwith in the said Burial Ground except for the reservation of the right of burial in the cases hereinafter specified:

And Whereas by an Order in Council dated the 28th day of April 1970 Notice of such Representation was given and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 13th day of July 1970, and that the said Order, or notice thereof, should be published in the Edinburgh Gazette and that copies of the said Order or notice should be fixed on the doors of Moulin church, or on some other conspicuous places within the parish or parishes affected by such Representation, one month before the said 13th day of July 1970:

And Whereas Notice of the said Representation and of the time when the same was ordered to be taken into consideration by the Privy Council has been duly published in the Edinburgh Gazette and fixed in manner required by the said Order in Council:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, as follows:—

- 1. That in terms of section 5 of the Burial Grounds (Scotland) Act 1855 burials be discontinued forthwith in Moulin Churchyard in the Burgh of Pitlochry and County of Perth except for the reservation of the right of burial in the said Burial Ground of:

Notice of Submission of Preliminary Draft Regulations

THE NATIONAL INSURANCE

(COLLECTION OF GRADUATED CONTRIBUTIONS) REGULATIONS 1970

IN accordance with Section 108 of the National Insurance Act 1965, the National Insurance Advisory Committee give notice that they have received from the Secretary of State for Social Services for consideration and report thereon the preliminary draft of regulations entitled the National Insurance (Collection of Graduated Contributions) Regulations 1970.

A short explanatory note of these regulations is appended to this notice.

EXPLANATORY NOTE

These Regulations revoke and consolidate with amendments the National Insurance (Collection of Graduated Contributions) Regulations 1960 as amended by the National Insurance (Collection of Graduated Contributions) Amendment Regulations 1962, hitherto in force. The Schedule to the regulations sets out the provisions of the Income Tax (Employments) Regulations 1962, as they apply to graduated contributions, thus providing for graduated contributions to be collected by the Inland Revenue along with P.A.Y.E. These income tax regulations have been further amended and consolidated, and the draft Collection of Graduated Contributions Regulations bring the graduated contributions regulations into line with the consolidated income tax provisions at various points.

THE Secretary of State gives notice that he intends to make an order imposing a speed limit of 40 m.p.h. on the trunk road (Route A.7) in Galashiels, from a point 432 yards south-east of the Burgh Boundary for a distance of 727 yards in a south-easterly direction to Bristol Terrace. This length of road is at present restricted to 30 m.p.h.



ARGENTINE: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968, he hereby recognises subject to the conditions hereinafter set out, the Official Certificates of which particulars are given in the First Schedule hereto as showing:—

- (a) that the meat to which they relate or from which the meat product to which they relate, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Secretary of State, and
- (b) that the dressing, packing and other preparation of the meat or the meat product was carried out with all necessary precautions for the prevention of danger to health.

The said Certificates are recognised subject to the following conditions:—

- (i) This recognition applies to meat and meat products imported from the Argentine Republic but does not apply to any such meat or meat product derived from mammals killed when wild.
- (ii) Where the Official Certificates are in the form of liabels, the recognition will apply only if the labels are securely affixed to the meat or the meat product or the package containing the meat or the meat product, and if the labels have not in any other circumstances or on any other occasion been used as Official Certificates.
- (iii) Where the Official Certificates are in the form of stamps, the recognition will apply only if the stamps are clearly impressed or otherwise marked on the meat or the meat product or the package containing the meat or the meat product.
- (iv) Recognition of the Official Certificates is restricted to those completed by the insention of one of the establishment numbers listed in the Second Schedule.

The Official Certificates reproduced in (1) and (2) of the Schedule to the Notice published in the Edinburgh Gazette dated 18th March 1952; in (1), (2) and (3) of the Schedule to the Notice published in the Edinburgh Gazette dated 24th July 1964, and in Parts I and II of the First Schedule to the Notice published in the Edinburgh Gazette dated 8th November 1968 are hereby revoked.






