

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 21st August 1970. at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £190,000,000.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates. 5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PRICES AND INCOMES ACT 1966

Report by the National Board for Prices and Incomes

COAL PRICES (SECOND REPORT)

1. IN their Report No. 124 on Coal Prices, the National Board for Prices and Incomes advised that the National Coal Board might need increases in revenue beyond the £15 million under review. The National Coal Board subsequently consulted the Minister of Technology about a price increase of about 10 per cent which it estimated would increase their revenues by about £65 million in the next full year. 2. On 18th November 1969, in pursuance of their powers under section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Technology referred this proposal to the National Board for Prices and Incomes for examination against the background of the Government's policies for the Nationalised industries. The Board has now made its second report entitled "Coal Prices (Second Report)" and in accordance with section 5(1) of the Prices and Incomes Act 1966, the Secretary of State for Employment and Productivity and the Minister of Technology hereby give notice that the report was first published as Command Paper Number 4445 on 13th August, 1970.

3. The Board has now made its report entitled "Costs and Efficiency in the Gas Industry." In accordance with section 5(1) of the Prices and Incomes Act 1966, the Secretary of State for Employment and Productivity and the Minister of Technology hereby give notice that the report was first published as Command Paper Number 4458 on 19th August 1970.

WAGES COUNCILS ACT 1959

BUTTON MANUFACTURING WAGES COUNCIL (GREAT BRITAIN)

PRICES AND INCOMES ACT 1966

Report by the National Board for Prices and Incomes COSTS AND EFFICIENCY IN THE GAS INDUSTRY

1. ON 12th January 1970 the National Joint Industrial Council for the Gas Industry reached an agreement providing for a flat rate increase in pay of 1s. $0\frac{1}{2}d$. per hour with effect from 18th January 1970. The Workers' Side of the Council gave an undertaking that they would continue to encourage co-operation in measures designed to achieve maximum efficiency of operations.

2. On 19th January 1970, in pursuance of their powers under Section 2(1) of the Prices and Incomes Act 1966, the First Secretary of State and Secretary of State for Employment and Productivity and the Minister of Technology referred to the National Board for Prices and Incomes for examination and report the effect of this agreement on costs, and the steps to be taken by the Gas Industry to absorb these costs without price increases by higher productivity and increased efficiency generally while achieving the industry's financial objective. Dated the 17th day of August 1970.


