READY-MADE AND WHOLESALE BESPOKE TAILORING WAGES COUNCIL (GREAT BRITAIN)

ROYAL BURGH OF ARBROATH

The Royal Burgh of Arbroath (Wellgate Level Crossing)
(Box Junction and Restriction of Waiting) Order 1970

THE Town Council of the Royal Burgh of Arbroath propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968.

When this Order comes into effect—

- (a) no person shall except upon the direction of or with the permission of a Police Constable in uniform drive a vehicle into a boxed area at Wellgate Level Crossing, Arbroath and thereafter drive it in such a direction that it becomes necessary owing to the presence of stationary vehicles for any part of the vehicle to remain at rest within that area; and
- (b) vehicles must not be left at any time in the following sections of Wellgate and Orchard Street, Arbroath, viz.:
 - (i) WELLGATE

North side—

From a point opposite the east kerb line of Robert Street eastwards to the level crossing gate. From the level crossing gate eastwards to the junction with Orchard Street.

South side—

From the east kerb line of Robert Street to the level crossing gate. From the level crossing gate to the junction with Orchard Street.

(ii) ORCHARD STREET

West side—

From the north kerb line of Wellgate northwards for a distance of 45 feet.

From the south kerb line of Wellgate southwards for a distance of 45 feet.

East side—

From a point 45 feet north of the north kerb line of Wellgate southwards to a point 45 feet south of the south kerb line of Wellgate.

Exceptions will permit waiting in those lengths of streets mentioned in paragraph (b) (i) and (ii) above for the purpose of—

- (a) picking up and setting down passengers;
- (b) loading or unloading goods;
 where necessary in connection with

(c) the maintenance of the roads; and

(d) the supply of gas, electricity and water; and by

(e) disabled drivers.

Full details of the proposals are in the draft Order which together with a map showing the proposed boxed area and the restricted lengths of road and the statement of the Council's reasons for proposing to make the Order may be examined at the Town Clerk's Office, Town House, Arbroath from Mondays to Fridays between 9 a.m. and 5 p.m.

 - (i) from a point 45 feet eastwards from Brown Constable Street to a point 45 feet westwards from Erskine Street, and
 - (ii) from a point 45 feet eastwards from Erskine Street to a point 45 feet westwards from Albert Street.
- (b) South side:
 - (i) from a point 45 feet eastwards from Brown Constable Street to a point 45 feet westwards from Erskine Street, and
 - (ii) from a point 45 feet eastwards from Erskine Street to a point 45 feet westwards from Albert Street.

3. RAGLAN STREET

South side from a point 45 feet eastwards from Albert Street to a point 45 feet westwards from Kemback Street.

4. WEST LYON STREET

- (b) South side from Cunningham Street to a point 45 feet westwards from Brown Constable Street.
- 4. To revoke in part The City of Dundee (Traffic Regulation No. 1) Order, 1966 in so far as inconsistent with the foregoing proposals.
- * Notes.
- 1. The proposed waiting restrictions do not apply on Sundays.
- 2. Waiting is permitted for any of the following purposes:
 - (a) to enable a person to board or alight from a vehicle;
 - (b) building operations or operations relating to the maintenance; improvement or reconstruction of the roads or the laying, erection, alteration or repair of sewers or main pipes or apparatus for the supply of gas, water or electricity or any telegraphic line;
 - (c) Police, Fire Brigade, Ambulance and certain other statutory purposes;
 - (d) collection or delivery of postal packets (by Post Office vehicles);
 - (e) funerals (if vehicle is in service of a funeral undertaking);
 - (f) licensed taxi-cabs at appointed stances;
 - (g) delivering goods to or collecting goods from premises adjoining the said roads subject to:
 - (i) a maximum waiting period of 30 minutes at any one place, and
 - the additional restrictions specified in paragraph 2(ii) of this Schedule.
 - (h) the removal of furniture subject to the additional restrictions specified in paragraph 2(ii) of this Schedule.
- 3. Provision has been made for the granting of exemptions from the Waiting Restrictions to severely disabled drivers.
