TENDERS FOR TREASURY BILLS

1. 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

Proposed Temporary Closure of the M90
**FROM HALBEATH ROUNDABOUT TO ADMIRALTY
ROUNDABOUT IN FIFE**

THE Secretary of State gives notice that he proposes to make an Order temporarily closing a section of the motorway M90 from the junction with route A907 at Halbeath roundabout southwards to its junction with route A92 at Admiralty roundabout, a distance of 3.5 miles. (Traffic Regulation) (Box Junction) (Cumbernauld Road/Alexandra Parade) Order 1970

THE Corporation of the City of Glasgow have made the above Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.
