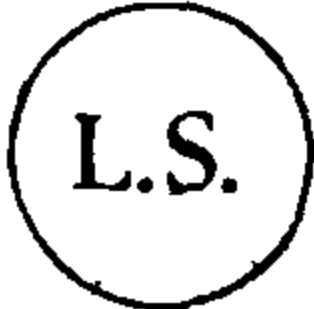

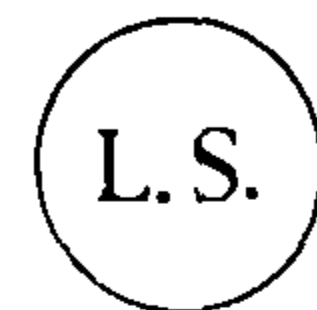

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968 he hereby recognises the Official Certificate of the design shown in Part I of the Schedule hereto for the importation from the Republic of Ireland of meat of a description given in Part II of the Schedule as showing (i) that the meat to which it relates was derived from mammals inspected before and after death and passed in accordance with criteria satisfactory to the Secretary of State, and (ii) that the dressing, packing and other preparation of the meat was carried out with all the necessary precautions for the prevention of danger to health.

The Official Certificate being in the form of a stamp, recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat or the package containing the meat.

The Notice published in the *Edinburgh Gazette* dated 1st April 1969 is hereby revoked.

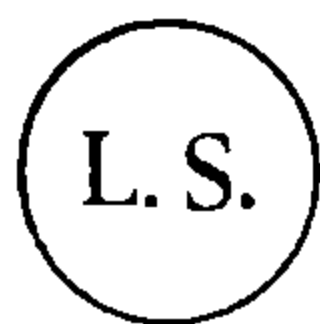

- (a) Portions of carcases, with or without bone, comprising recognisable wholesale or retail cuts which contain no associated lymphatic gland from which has been removed in preparing or trimming the meat, any pleura, peritoneum or lymphatic gland;
- (b) the tongue from any bovine animal from which a sub-maxillary lymphatic gland has been removed;
- (c) offal of the following description from which any lymphatic gland has been removed:—  
stomachs (tripes and maws);
- (d) minced or chopped meat other than liver with or without the addition of any spices, cereal products, salt, flavouring, vegetable or other ingredient.

Recognition does not extend to boneless veal appearing to an authorised officer to be from calves less than three months old.

NOTICE is hereby given that on the 20th day of November 1970 the Secretary of State amended the above Development Plan.

A copy of the Development Plan amended by the Secretary of State has been deposited at the offices of the County Planning Officer, County Offices, Dumbarton.

The proposals relate to the major part of the present commercial area of Alexandria together with certain areas of residential and service industrial character which are ripe for redevelopment and which are contained in the undernoted boundaries. The area lies immediately south-west of Comprehensive Development Area No. 3 which was approved by the Secretary of State in 1962.

West boundary—the centre line of Main Street from Millburn Road to Church Street—the south and west boundaries of the former Main Street School—the rear boundaries of the properties on the west side of Main Street to the Vale of Leven Bowling Green.

North boundary—the south boundary of the Vale of Leven Bowling Green.

North-east boundary—the centre line of Main Street from the Vale of Leven Bowling Green to the junction with Bank Street; the centre line of Bank Street to the east side of the property at 160/162 Bridge Street.

East boundary—the east and south boundaries of the property at 160/162 Bridge Street—the south boundary of the properties at 158/108 Bridge Street—the east boundary

of the property at 37 Thomas Street—the centre line of Thomas Street—the east boundary of the property at 4/8 Thomas Street—the east boundary of the school meals centre.

South boundary—the centre line of Leven Street and Bridge Street—the west boundary of the Balloch branch railway line to Main Street at Millburn Road.

The Comprehensive Development Area embraces approximately 45 acres of land.

Each copy of the amended Development Plan so deposited is available for inspection by the public, free of charge, between the hours of 9 a.m. and 4.30 p.m. from Monday to Friday.

The amendment to the Development Plan became operative as from the 30th day of November 1970, but if any person aggrieved by the amendment, desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning (Scotland) Act 1947, or on the ground that any requirements of that Act or any Regulation thereunder has not been complied with in relation to the making of the Amendment, he may within 6 weeks from the 30th day of November 1970, make an application to the Court of Session.

## (Restriction of Entry)

(St. George's Road/West Princes Street)  
Order 1970

THE Corporation of the City of Glasgow have made the above Order under Section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.
