### TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 4th December 1970, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £180,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 7th December 1970, to Friday, the 11th December 1970, inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PROHIBITION OF WAITING—CLEARWAYS  
GLASGOW-CARLISLE TRUNK ROAD (A.74)

THE Secretary of State gives notice that he intends to make an order under the Road Traffic Regulation Acts 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to amend the provisions of the Glasgow-Carlisle Trunk Road (Clearways) Order 1967 so that vehicles will be prohibited from waiting on the additional length of trunk road specified in the Schedule hereto.

Kinross will become the highway authority for the new roads.

With the Muirmont to Craigend Special Road Scheme 197, the Craigend to Broxden Special Road Scheme 197, and the Craigend to Barnhill Special Road Scheme 197, these draft schemes and orders set out the Secretary of State's proposals for a further section of the Inverkeithing to Perth (M.90) motorway and a southern bypass of the town of Perth. This scheme was embodied in an Order made by the Tribunal dated 6th April 1961 which was varied by a subsequent Order dated 21st January 1963.

The Disputes which caused Tariff "C" to be referred to the Tribunal in the previous proceedings were not concerned in any way with the formula for calculating the royalty payable to the Licensing Body under licenses issued pursuant to Tariff "C". The formula was arrived at by negotiation between the Licensing Body and the two interested parties and was incorporated in formal agreements dated 17th December 1959 in the case of the Cinema Exhibitors Association and 8th April 1960 in the case of the Association of Independent Cinemas Limited.

The Licensing body and the Interested parties have reviewed and revised the formula by which royalties should be calculated under licenses issued pursuant to Tariff "C" and have reached agreement on a new formula and, by agreement, the tariff has been revised to give effect to this new formula. The essential feature of the new formula is that under it the royalties payable are calculated as a percentage of the actual gross receipts from cinematographic performances at the cinema in place of the former method whereby an estimate of each cinema's receipts was made.

The Reference to the Tribunal is made jointly by the Licensing Body and the Interested Parties and they are jointly applying to the Tribunal to vary the Order dated 6th April 1961 by making an Order substituting the terms of the revised Tariff "C" for the tariff embodied in the Order of 6th April 1961 as amended by the Order of 21st January 1963.
