A PROCLAMATION

REVOKING A PROCLAMATION, DATED THE TWELFTH DAY OF DECEMBER 1970,
DECLARING THE EXISTENCE OF A STATE OF EMERGENCY

ELIZABETH R.

Whereas by Our Proclamation, dated the twelfth day of December, one thousand nine hundred and seventy, We declared that a State of Emergency existed within the meaning of the Emergency Powers Act 1920, as amended by the Emergency Powers Act, 1964:

And whereas it appears to Us that the State of Emergency has now ceased to exist and that it is expedient that the said Proclamation should be revoked accordingly:

Now, therefore, We do, by and with the advice of Our Privy Council, hereby proclaim that the said Proclamation is revoked.

Given at Our Court at Buckingham Palace this seventeenth day of December in the year of our Lord one thousand nine hundred and seventy, and in the nineteenth year of Our Reign.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 18th December 1970, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £140,000,000.

(being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
5. Tenders must be made through a London Banker, Discount House or Broker.
6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
7. Members of the House of Commons are not precluded from tendering for these Bills.
8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

PAY OF THE ARMED FORCES

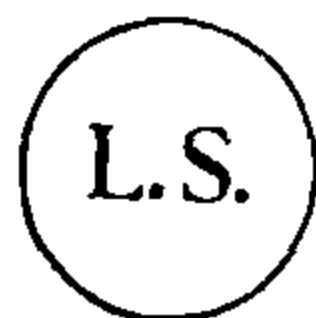
