TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 18th December 1970, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £140,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 21st December 1970, to Thursday, the 24th December 1970 inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Different rates of interest apply according to whether the principal of a loan is repaid by instalments or at maturity.

PRICES AND INCOMES ACT 1966

Report by the National Board for Prices and Incomes

PAY OF THE ARMED FORCES

ON 2nd November 1967, in pursuance of their powers under section 3(2) of the Prices and Incomes Act 1966, the Secretary of State for Economic Affairs, the Chancellor of the Exchequer and the Secretary of State for Defence, acting jointly, instructed the National Board for Prices and Incomes to keep under continuous review the pay and allowances of members of naval, military or air forces of the Crown and of any women's service administered by the Defence Council.

2. The Board has now made its fourth report, and in accordance with section 5(1) of the Act, the Prime Minister and Minister for the Civil Service, the Chancellor of the Exchequer, the Secretary of State for Defence and the Secretary of State for Employment hereby give notice that this report, entitled "The Pay of Senior Officers" was first published as Command Paper Number 4513 on 8 December 1970.

WAGES COUNCILS ACT 1959

SACK AND BAG WAGES COUNCIL (GREAT BRITAIN)

THE Sack and Bag Wages Council (Great Britain) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Sack and Bag) Order 1969 (Order S.B.(68)) and (2) the revocation of Order S.B.(68). Particulars of the proposals are contained in the Wages Council's Notice S.B.(70) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 18 December 1970. It is desirable that persons making objections should state the precise nature of their objections and quote the number of the Wages Council's Notice of Proposals S.B.(70).
