#### TENDERS FOR TREASURY BILLS

- 1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Thursday, the 24th December 1970, at 12.15 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £220,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 28th December 1970, to Friday, 1st January 1971, inclusive, and will be due 91 days after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England:

#### PUBLIC INQUIRY

Factories Act 1961

THE First Secretary of State and Secretary of State for Employment and Productivity published draft regulations entitled The Highly Flammable Liquids Regulations and gave notice on 24th June 1969 in accordance with Section 180 of the Factories Act 1961 and Schedule 4 to that Act, of her intention to make Special Regulations as in that draft.

Certain general objections were made to the draft regulations and not withdrawn. The Secretary of State for Employment has now, in accordance with the procedure laid down in the above Schedule, directed an Inquiry to be held and has appointed Mr John S. Wordie, M.A., LL.B., as Commissioner for this purpose. The Inquiry will be held in public and any objector and other person who, in the opinion of the Commissioner, is affected by the draft regulations may appear at the Inquiry either in person or by counsel, solicitor or agent.

In accordance with the Factories Act (Conduct of Inquiries) Rules 1938, the Commissioner hereby gives notice that he will open the Inquiry at 10.15 a.m. on Tuesday, 2nd February 1971, at Church House, Great Smith Street, Westminster, London S.W.1.

It is requested that notification be given to the Commissioner not later than 11th January 1971 of any person or representative likely to appear at the Inquiry.

# DANGEROUS DRUGS ACT 1965 WITHDRAWAL OF AUTHORITIES JOHN MAURICE O'GRADY

WHEREAS JOHN MAURICE O'GRADY, M.B., B.Ch., whose registered address is 16 Dorchester Avenue, Palmers Green, London N.13, is, under Regulations 4 and 10 of the Dangerous Drugs (No. 2) Regulations 1964, authorised, by virtue of being a duly qualified medical practitioner, to possess and supply drugs and other substances to which the said Regulations respectively apply so far as may be necessary for the practice or exercise of his said profession:

And whereas the said John Maurice O'Grady has been convicted of offences against the Dangerous Drugs Act 1965 and cannot in the opinion of the Secretary of State properly be allowed to remain a person authorised as aforesaid:

Now therefore, in pursuance of the power conferred on him by Regulation 22 of the said Regulations, the Secretary of State hereby withdraws from the said John Maurice O'Grady the authorities aforesaid under the said Regulations 4 and 10:

And, in pursuance of Regulation 11 of the said Regulations, the Secretary of State hereby directs that it shall not be lawful for the said John Maurice O'Grady to give prescriptions prescribing any substance for the time being falling within Part I of the Schedule to the Dangerous Drugs Act 1965.

# SPECIAL ROADS ACT 1949 ROADS (SCOTLAND) ACT 1970 EARLSTON SIDE ROADS ORDER

THE Secretary of State has made the Edinburgh Newcastle-Upon-Tyne Trunk Road (Earlston Side Roads) Order 1970, for stopping up a length of Mill Road and of Haughhead Road, for building a new length of road at Earlston in the County of Berwick and for Berwick County Council becoming the highway authority for that new length of road.

The Newbridge to Lathallan Special Road

THE Secretary of State gives notice that he proposes to make the following schemes and order:—

  - (a) to vary Schedules 6-11 to the Newbridge-Lathallan Special Roads (Side Roads) Order 1968 as varied by the Newbridge-Lathallan Special Roads (Side Roads) (Variation) Order 1968 all on or in the vicinity of the Myre to Burghmuir section of Newbridge to Lathallan Special Road; and
  - (b) to provide for the County Council of West Lothian becoming the highway authority for the new roads within the County Boundary on the 16th day of May after the date on which notice is given by the Secretary of State to the Council that the said roads have been completed and opened to through traffic.

# THE BEARSDEN SMOKE CONTROL AREA ORDER No. 3 1970

1. The authorised fuels are:—Anthracite and semi-anthracite, briquetted fuels carbonised in the process of manufacture, coke, electricity, gas, low temperature carbonisation fuels and low volatile steam coals, multi heat briquettes manufactured by the National Coal Board and Rexco briquettes manufactured by Scottish Rexco Ltd.

3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Municipal Offices, Boclair, Bearsden, between the hours of 8.45 a.m. and 5.15 p.m. Monday to Friday of each week during the period of six weeks from the 28th day of December 1970.

4. Within the said period any person who will be affected by the Order may, by Notice in writing to the Secretary of State, Scottish Development Department, St. Andrew's House, Edinburgh 1, object to the confirmation of the Order.
