

SCOTTISH HOME AND HEALTH DEPARTMENT THE IMPORTED FOOD SCOTLAND) REGULATIONS 1968 PARAGUAY: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968, he hereby recognises subject to the conditions hereinafter set out, the Official Certificate of

- (a) that the meat from which the meat product to which it relates was prepared, was derived from mammals inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Secretary of State.
- (b) that the dressing, packing and other preparation of the meat and the meat product was carried out with all necessary precautions for the prevention of danger to health.

The said Certificate is recognised subject to the following conditions:—

- (i) This recognition applies to meat products imported from Paraguay but does not apply to any such meat product derived from mammals killed when wild.
- (ii) The Official Certificate being in the form of a stamp, the recognition will apply only if the stamp is clearly impressed or otherwise marked on the meat product or the package containing the meat product.
- (iii) Recognition of the Official Certificate is restricted to the extent indicated in the second Schedule hereto.
- (iv) Part II of the Schedule to the Notice published in the Edinburgh Gazette dated 19th July 1938, and the Notices published in the Edinburgh Gazette dated 20th May 1969, 25th July 1969, and 15th May 1970, are hereby revoked.


