


BUILDING SOCIETIES

The Building Societies (Authorised Banks) (No. 44) Order 1970

THE Chief Registrar of Friendly Societies, with the consent of the Treasury, pursuant to the powers conferred on him by Section 59(2) of the Building Societies Act 1962 and to all other powers enabling him in that behalf, hereby makes the following Order:

- 1. N. M. Rothschild & Sons Limited is hereby designated so as to be authorised to hold funds of building societies as mentioned in Section 59(1) of the Building Societies Act 1962.
- 2. The Building Societies (Authorised Banks) (No. 2) Order 1961 is hereby varied by the deletion in paragraph 1 of N. M. Rothschild & Sons.
- 3. This Order may be cited as the Building Societies (Authorised Banks) (No. 44) Order 1970.



SCOTTISH HOME AND HEALTH DEPARTMENT

THE IMPORTED FOOD (SCOTLAND) **REGULATIONS 1968**

NORWAY: OFFICIAL CERTIFICATE

THE Secretary of State for Scotland gives notice that in exercise of the powers conferred on him by the Imported Food (Scotland) Regulations 1968 he hereby restricts recognition of the Official Certificate reproduced in the Schedule

Scottish Home and Health Department, 12/14 Carlton Terrace, Edinburgh, EH7 5DG.

NOTE: — Imports of uncooked meat and meat products from certain countries are restricted, and in some cases prohibited, on animal health grounds by the Importation of Carcases and Animal Products Order 1954, as amended. The recognition of an Official Certificate for public health purposes does not give exemption from such restrictions or prohibitions.
