#### Overtime and Shiftworking

ON 29th April 1969 the First Secretary of State and Secretary of State for Employment and Productivity in pursuance of her powers under Section 2(1) of the Prices and Incomes Act 1966, referred to the National Board for Prices and Incomes for examination the question of the relationship between the length and pattern of the working week including hours of overtime and shift work, and earnings, costs and productivity.
