STOPPING UP OF HIGHWAYS IN THE BURGH OF DUMBARTON

THE Secretary of State for Scotland hereby gives notice that he has made an Order under Section 46 of the Town and Country Planning (Scotland) Act 1947 as read with the Transfer of Functions (Roads, Bridges and Ferries) Order 1955, as amended by Section 96 of the Town and Country Planning (Scotland) Act 1969 and as extended by Section 89 of that Act authorising the stopping up of Graham Road, Dumbarton. The title of the Order is the Stopping Up of Highways (Burgh of Dumbarton) (Graham Road) Order 1971.

Copies of the Order, which specifies the actual length of road to be stopped up, and of the relative plan may be inspected at the Offices of the Scottish Development Department, 43 Jeffrey Street, Edinburgh or at the offices of the Town Clerk, Dumbarton.

Any person aggrieved by the Order, and desiring to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of part III of the Town and Country Planning (Scotland) Act 1947, as amended, or that any requirement of the Sixth Schedule of that Act has not been complied with in relation to the order, may within six weeks from 22nd October 1971 apply to the Court of Session for the suspension or quashing of the Order or of any provision contained therein.

PROPOSED TEMPORARY CLOSURE OF BRIDGEGATE, IRVINE (TRUNK ROAD A.78)

THE Secretary of State proposes to make an order closing to all traffic Bridgegate, Irvine (Trunk Road A.78). Northbound traffic—The same route in the opposite direction.

- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.




