THE RADIOACTIVE SUBSTANCES ACT 1948 APPROPRIATE MINISTER DESIGNATION (No. 4) ORDER

NOTICE is hereby given that Her Majesty in Council was pleased on the 27th October 1971 to approve an Order in Council, made in pursuance of Section 5(6) of the Radioactive Substances Act 1948, entitled the Radioactive Substances Act 1948 Appropriate Minister Designation (No. 4) Order 1971.
