FACTORIES ACT 1961

THE Secretary of State for Employment hereby gives notice that on 3rd November 1971 he made the Baking and Sausage Making (Christmas and New Year) Order 1971 under section 117 of the Factories Act 1961. This Order enables women, who have attained the age of eighteen, to be employed in England and Wales on the afternoons of Saturdays, 11th, 18th and 25th December 1971 and 1st January 1972, and on Sundays, 12th, 19th and 26th December 1971 and 2nd January 1972, in the manufacture of meat pies, sausages or cooked meats, or in the pre-packing of bacon; and on the afternoons of Saturdays, 11th and 18th December 1971, and on Sundays, 12th and 19th December 1971, in the manufacture of bread or flour confectionery (including fruit pies but not biscuits).

This Order also enables women, who have attained the age of eighteen, to be employed in Scotland on the afternoons of Saturdays, 11th, 18th and 25th December 1971 and 1st January 1972, and on Sundays, 12th 19th and 26th December 1971 and 2nd January 1972, in the manufacture of meat pies, sausages or cooked meats, or in the pre-packing of bacon; and on Sundays, 19th and 26th December 1971 in the manufacture of bread or flour confectionery (including fruit pies but not biscuits).

Petroleum Production Licences

THE Secretary of State for Trade and Industry hereby gives notice that in pursuance of the powers conferred upon him by section 2(1) of the Petroleum (Production) Act 1934 and by that section as supplied by section 1(3) of the Continental Shelf Act 1964 and in accordance with the provisions of those Acts and the Petroleum (Production) Regulations 1966, he has granted to the under-mentioned persons production licences in respect of the blocks shown against the name of those persons. LILYBANK AND NORTH KILDUFF DIVERSIONS

**PROPOSED "NO U TURN" ON TRUNK ROAD
(ROUTE A.82) AT OLD KIRKPATRICK
DUNBARTONSHIRE**

THE Secretary of State proposes to make an order prohibiting vehicles which are travelling on either carriageway of the trunk road (Route A.72) at Old Kirkpatrick from making a U-turn into the opposite carriageway.

The press notice which appeared on 29th and 30th October 1971 concerning a proposal to ban right turns from either carriageway into the opposite carriageway is cancelled.

TENDERS FOR TREASURY BILLS

1. 6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 1, 2 and 13 of the Import Duties Act 1958.

Viz.:—*The Import Duties (General) (No. 7) Order 1971.*

This Order, which comes into operation on 1st January 1972:—

- (1) consolidates the Import Duties (General) (No. 7) Order 1970 and the Orders amending it,
- (2) completes the process begun by the Import Duties (General) (No. 4) Order 1968 and continued in subsequent Orders, in that it again reduces, as the fourth and last of a series of reductions, the full rate of import duty (and, where applicable the Commonwealth preference rate) on a wide range of goods in accordance with the undertakings given by the United Kingdom at Geneva and set out in the June 1967 Protocol to the General Agreement of Tariffs and Trade (the Kennedy Round; Cmnd. 3347),
- (3) effects some further simplifications of the tariff by again reducing the number of sub-divisions in certain headings and entirely eliminating those in others where previously differing rates of duty have been brought to the same level as a result of the reductions referred to in (2) above,
- (4) impose new duties, generally at the rate of 85 per cent of the full rates, on imports of certain cotton textiles (as defined in the Order) from countries in the Commonwealth Preference Area other than the Republic of Ireland,
- (5) provides in some descriptions and rates of duty for a change to metric units where consultation has shown their use to be desired by the industries concerned,
- (6) adapts the text of certain chapter notes and headings to take account of the consolidation of the law relating to the hydrocarbon oil duty in the Hydrocarbon Oil (Customs and Excise) Act 1971,
- (7) effects minor alterations to the tariff, including modifications in certain headings to facilitate implementation of the provisions of section 1 of the Finance Act 1971 introducing the Generalised System of Preferences and
- (8) incorporates amendments to tariff headings, section and chapter notes and the interpretative rules to give effect to a Recommendation of the Customs Co-operation Council designed to bring the Brussels Nomenclature (on which the United Kingdom Tariff is based) abreast of various technological developments and in other respects to improve its texts.

The Order comes into operation on 1st January 1972 and has been published as Statutory Instrument 1971 No. 1813.

 entitled

*The National Insurance (Claims and Payments and
 Miscellaneous Provisions) Regulations 1971*

IN accordance with Section 108 of the National Insurance Act 1965, the National Insurance Advisory Committee give notice that they have received for consideration and report

thereon the preliminary draft of regulations entitled the National Insurance (Claims and Payments and Miscellaneous Provisions) Regulations 1971.

A short explanatory note on these regulations is appended to this notice.

The Committee will take into consideration any objection made by or on behalf of persons affected, received by them not later than 10th December 1971.

EXPLANATORY NOTE

Regulation 2 amends regulation 2 of the National Insurance (Claims and Payments) Regulations 1971 (claims to be made to the Secretary of State in writing) substitutes a new paragraph for paragraph 1 of Schedule 3 to the National Insurance (Claims and Payments) Regulations 1971 (special provisions relating to claims for unemployment benefit) and makes a minor amendment to paragraph 3 of that Schedule (claims in advance for sickness or invalidity benefit by a woman where it has been certified that it is to be expected that she will be confined). The regulation also expressly inserts in Section 49(4) of the National Insurance Act 1965 (limitation on payment of benefit for period before benefit is claimed) references to 12 months: regulation 2 of the National Insurance (Claims and Payments) Amendment Regulations 1969, which had varied the said Section 49(4) by substituting for the references in that Section to 6 months references to 12 months, was revoked by the National Insurance (Claims and Payments) Regulations 1971 and the insertion of express references to 12 months in that Section by these regulations is to clarify the position.

Regulation 3 revokes head (a) of the proviso to regulation 2(2) of the National Insurance (Contributions) Regulations 1969 (special provisions relating to persons who reside at more than certain distances from an Employment Exchange).

Regulation 4 adds a new provision to the National Insurance and Industrial Injuries (Miscellaneous and Consequential Provisions) Regulations 1966 whereby a decision disallowing a claim for unemployment benefit may, in certain circumstances, be treated as a disallowance of further claims for unemployment benefit and makes a minor consequential amendment to regulation 2 of those regulations (forward disallowance of sickness benefit).

Regulation 5 amends regulation 15 of the National Insurance (Determination of Claims and Questions) (No. 2) Regulations 1967 (review of decisions involving payment or increase of benefit) removing, in cases where a decision disallowing a claim for unemployment benefit is treated as a disallowance of any further claim, the absolute bar on payment of benefit, or a higher rate of benefit, for a period of more than 12 months before an application for review is made.

Regulation 6 adds two new sub-paragraphs to regulation 7 of the National Insurance (Unemployment and Sickness Benefit) Regulations 1967 (days not to be treated as days of unemployment or incapacity for work) related to persons who, having been directed to attend for interview in connection with the obtaining of employment or for the purpose of making a written declaration in connection with satisfaction of the conditions for receipt of unemployment benefit, fail to do so without good cause.

Regulation 7 amends regulation 13(2) of the National Insurance (General Benefit) Regulations 1970 (suspension of payment of certain benefits awarded by a local tribunal where an appeal is made to the National Insurance Commissioner within 21 days).
