#### PRIVATE LEGISLATION PROCEDURE (SCOTLAND) ACT 1936

NOTICE is hereby given in terms of section 1(4) of the Private Legislation Procedure (Scotland) Act, 1936, that the Secretary of State, the Chairman of Committees of the House of Lords and the Chairman of Ways and Means in the House of Commons having considered representations by Lloyds & Bolsa International Bank Limited that it is expedient that the under-mentioned Parliamentary powers to be operative in Scotland and elsewhere which the Bank desire to obtain should be conferred by one enactment have decided that the said powers would more properly be obtained by the promotion of a Private Bill than by the promotion of a Private Bill and of a Provisional Order under the said Act.

- To transfer to LBI Trust Company certain executor and trustee business of the existing banks.
- 3. To enact provisions in furtherance of and consequential upon such respective transfers.

#### THE GLASGOW RENFREW MOTORWAY (STAGE I)

A Scheme under section 1, 2 and 9 of the Special Roads Act 1949, authorising the provision of special roads (motorways) at the road junctions described below for the exclusive use of traffic of the classes described in paragraph 1 hereof to connect the special roads described in paragraph 1 hereof to existing all purpose surface roads, viz.:—
  - (a) Junction of the motorway with Carnoustie Street
  - (b) Junction of the motorway with Weir Street
  - (c) Junction of the motorway with Seaward Street
  - (d) Junction of the motorway with Dumbreck Road
  - (e) Junction of the motorway with Helen Street
- 3. An Order under sections 3 and 7 of the Special Roads Act 1947, authorsing the Corporation:—
  - (a) to improve, raise, lower or otherwise alter roads
  - (b) to stop up roads and construct new roads
