PRIVATE LEGISLATION PROCEDURE (SCOTLAND) ACT 1936

FRIENDS OF THE CLERGY CORPORATION

NOTICE is hereby given in terms of Section 1(4) of the Private Legislation Procedure (Scotland) Act 1936, that the Secretary of State, the Chairman of Committees of the House of Lords and the Chairman of Ways and Means in the House of Commons having considered representations by the Friend of the Clergy Corporation and the Poor Clergy Relief Corporation that it is expedient that the under-mentioned Parliamentary powers to be operative in Scotland and elsewhere which the Corporations desire to obtain should be conferred by one enactment have decided that the said powers would more properly be obtained by the promotion of a Private Bill than by the promotion of a Private Bill and of a Provisional Order under the said Act.

- 1. To amalgamate the Friend of the Clergy Corporation and the Poor Clergy Relief Corporation in a new corporate body and to provide for its incorporation on the 1st September 1972 by the name of the Friends of the Clergy Corporation (hereinafter referred to as "the Corporation") to define the objects and powers of the Corporation and to authorise subsequent variation of those objects and powers as if they formed part of a scheme brought into effect by order of the Charity Commissioners under section 18 of the Charities Act 1960;
- 2. To transfer to the Corporation all property of the Friend of the Clergy Corporation and the Poor Clergy Relief Corporation and to provide for the transfer of liabilities of those Corporations, the saving for agreements, deeds, actions etc. and construction in favour of the new Corporation of bequests made in favour of either of the two transferring Corporations;
- 3. To confer a power to sell, mortgage, etc. lands to provide for the application by the Corporation of the property funds and income of the two transferring Corporations and to enact provisions relating to the investment of funds of the Corporation and the establishment and maintenance of investment pools;

- 4. To authorise the Corporation to make regulations with respect to the management of the Corporation and the government and administration of its affairs including the holding of meetings, the appointment of officers and of a Committee of Management;
- 5. To name the first President and Vice Presidents of the Corporation and officers and the members of its Committee of Management; and
- 6. To enact incidental and consequential provisions. Dated this 19th day of November 1971.

Diseases of Animals

The Brucellosis (Area Eradication) (Scotland) Order 1971 NOTICE is hereby given that in exercise of the powers conferred upon the Secretary of State by Sections 1 and 5 of the Diseases of Animals Act 1950, as read with the Transfer of Functions (Animal Health) Order 1955, and the Diseases of Animals (Extension of Definitions) Order 1971, and as extended by Section 106 (iii) of the Agriculture Act 1970, and of all other powers enabling him in that behalf,

he has made the following order known as the Brucellosis (Area Eradication) (Scotland) Order 1971, which came into operation on 1st November 1971.

This Order contains general provisions which will apply in all brucellosis Eradication or Attested Areas. They include a prohibition against the movement of cattle into such an Area (except cattle going direct to a slaughter house or knacker's yard, or under licence or on certain transit journeys), a power to prohibit the movement of cattle on to or off particular premises in such an Area, and ancillary provisions designed to prevent the introduction or spreading of brucellosis.

By virtue of the Brucellosis (Eradication Areas) (Scotland) Order 1971, five areas of Scotland have already been designated by the Secretary of State to be Eradication Areas for purposes connected with the control of brucellosis. The provisions of the present Order will take effect in those Areas designated in the Schedule to the Eradication Areas Order as the No. 1 and No. 2 Eradication Areas as from 1st November 1971.
