

## TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 17th December 1971, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act, 1968, to the amount of £180,000,000.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 5 of the Import Duties Act 1958, and Section 2 of the Finance Act 1971.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday, the 20th December 1971, to Friday, the 24th December 1971, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

This Order provides for relief from import duty on certain cotton yarn and manufactures of woven cotton from the Commonwealth preference area.

## ERSKINE BRIDGE

## Pre-paid vouchers

BOOKS of pre-paid vouchers are now available for vehicles using Erskine Bridge. The vouchers are sold in books of 40 costing  $\pounds 6$  for a book of 15p vouchers and  $\pounds 20$  for a book of 50p vouchers.

From 3rd January 1972 these vouchers will be accepted at the toll booths in lieu of the cash equivalent. Applications, accompanied by a remittance for the appropriate amount, should be made (by post only) to the Bridge Master, Adminsitration Building, Erskine Bridge, Bishopton, Renfrewshire, at least 10 days before the vouchers are to be used or by 22nd December in the case of vouchers required for use on 3rd January 1972.
