# THE POST OFFICE TELEPHONE AMENDMENT

(No. 2) SCHEME 1972

Made 3rd May 1972

Coming into operation 8th May 1972

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

# COMMENCEMENT, CITATION AND EXTENT

- 1.—(1) This Scheme shall come into operation on the 8th day of May 1972 and may be cited as the Post Office Telephone Amendment (No. 2) Scheme 1972.
- (2) This Scheme shall apply and extend to the United Kingdom and the Isle of Man.

### INTERPRETATION

- 2.—(1) This Scheme shall be read as one with the Post Office Telephone Scheme 1971 (Post Office Scheme Tl/1971) (hereinafter called "the principal Scheme") as amended by the Post Office Telephone Amendment (No. 1) Scheme 1971 (Post Office Scheme T8/1971).
- . (2) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

# CONNECTION CHARGES

- 3. In Schedule 4 to the principal Scheme (which prescribes maximum connection charges) for item 1 there shall be substituted the following item:—
  - "1. Exchange line of which the chargeable length does not exceed 3 miles ... 35.00"

# CORPORATION OF THE CITY OF ABERDEEN

Road Traffic Regulation Act 1967

- 1. THE Corporation of the City of Aberdeen propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, which, when it comes into effect, will:—
  - (a) prohibit vehicles from proceeding otherwise than clockwise round the island to be constructed at the north-east end of Queen Street;
  - (b) prohibit vehicles from entering Queen Street and the road commonly known as Poultry Market Lane from the King Street/East North Street/ West North Street junction;
  - (c) prohibit vehicles from entering the King Street/ East North Street/West North Street junction from Queen Street and the road commonly known as Poultry Market Lane except for vehicles acting under the direction of the Chief Constable;
  - (d) prohibit the waiting of vehicles, except upon the direction or with the permission of a police constable in uniform of unless for certain purposes mentioned in the Order, including the waiting of vehicles for so long as may be necessary to enable goods to be loaded or unloaded:—
    - (i) at any time on the south-east side of Queen Street and on that part of the north-west side of Queen Street north-eastwards of a point 76 metres north-east of a point opposite the southmost building line of Greyfriars Church; and
    - (ii) between 8 a.m. and 6 p.m. on weekdays for a period longer than 45 minutes or if a period of less than 15 minutes has elapsed since the

termination of the last period of waiting (if any) on the north-west side of Queen Street from a point opposite the southmost building line of Greyfriars Church north-eastwards for a distance of 76 metres;

- (e) revoke the existing prohibition of vehicles from proceeding in Queen Street otherwise than east-wards;
- of prohibit vehicles of unladen weight in excess of 30 cwts., with the exception of public service vehicles and, in circumstances of emergency, police, fire service and ambulance vehicles, from using St. Nicholas Street and that part of George Street between Schoolhill and St. Andrew Street except for access to premises in those streets; and
- (g) prohibit vehicles from using Erskine Street between Elmbank Terrace and Powis Terrace.

Copies of the draft Order containing full details of the proposals, maps showing the roads to which the draft Order refers and statements of the Council's reasons for proposing to make the Order may be examined at the Town Clerk's Office, Town House, Aberdeen, between 8.45 a.m. and 12.45 p.m. and between 2 p.m. and 5.30 p.m. from Mondays to Fridays.
- 3. Any person wishing to object to the proposed Order should send details of the grounds for objection to the undersigned by Thursday, 22nd May 1972.

# Road Traffic Regulation Act 1967 THE AYR COUNTY COUNCIL

(Street Parking Places) Order 1972

- 1. AYR County Council have made an Order under Sections 28(1), 31(1) and 84D(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.
- 2. This Order, which will come into operation on 3rd July 1972, revokes all existing Orders and Regulations relating to street parking place arrangements in the Landward Area of the County of Ayr, and re-authorises the use of parking places in accordance with the said Act of 1967, subject to certain deletions, additions and minor modifications relating to the locations of the parking places and the Regulations as to their use. The Order specifies the exact areas of the street parking places (a list of which is given in the Schedule to this Notice) and authorises their use by motor cars, motor cycles and invalid carriages only. The Order limits the period of waiting in a parking place to 12 hours at any one time; specifies the position in which vehicles may wait in a parking place; prohibits the sale of goods from a vehicle whilst in a parking place; regulates the use of parking places to prevent drivers causing obstruction or annoyance to other road users; and makes provision for the removal from a parking place of any vehicle left there in contravention of the Order, and for the safe custody of such vehicle. An exemption is made in the Order to enable a disabled person's vehicle to wait in a parking place for longer than the period of time specified in the Order if there is displayed on the said vehicle in the relevant position a disabled person's badge issued by a local authority in exercise of its powers under Section 21(1) of the Chronically Sick and Disabled Persons Act 1970.
- 3. A copy of the Order and maps showing in detail the parts of roads affected are available at the County Clerk's Department, County Buildings, Ayr, where they may be examined between 9 a.m. and 5 p.m. from Mondays to Fridays inclusive.

4. Any person who wishes to question the validity of the Order or of any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the ground that any requirement of that Act, or of any Instrument made under it, has not been complied with in relation to the Order, may, within six weeks from 25th April 1972, apply to the Court of Session for this purpose.
