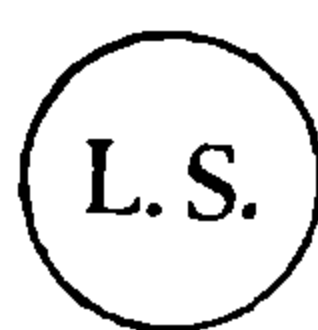

## ARGYLL COUNTY COUNCIL

*The County of Argyll (Regulation of Traffic)  
(Shore Street, Bowmore, Island of Islay) Order 1972*

1. ON 17th May 1972 the County Council of the County of Argyll made the above-named Order under Sections 1(1), (2) and (3) and 84D(1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968.

2. This Order, which comes into operation on 30th June 1972 makes it unlawful to leave a vehicle between 9 a.m. and 6 p.m. in Shore Street, Bowmore, Island of Islay, as follows:—

- (a) for longer than 30 minutes on the part of Shore Street between a point 140 yards east of the east side of its junction with Hawthorn Lane and a point 10 yards east of its junction with Main Street, on the seaward side, on Sundays to Saturdays inclusive;
- (b) on that part of Shore Street between a point 140 yards east of the east side of its junction with Hawthorn Lane and its junction with Main Street, on the landward side, on Sundays to Saturdays inclusive.

3. Exceptions in the Order enable a vehicle to wait for as long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded, and enable vehicles to be used in connection with certain maintenance and other works or by disabled persons.

4. The Order revokes the County of Argyll (Regulation of Traffic) (Shore Street, Bowmore, Island of Islay) Order 1969.

5. A copy of the Order and a map showing the road affected may be examined at the County Offices, Lochgilphead, or at the District Council Office, Bowmore, Islay, during normal office hours on Mondays to Fridays inclusive.

6. Any person who wishes to question the validity of the Order or of any provision contained in it on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 or on the ground that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may, within six weeks from 17th May 1972 apply to the Court of Session for this purpose.
