### TENDERS FOR TREASURY BILLS

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 3(6), 6(1), 14, 21(2) and 43(1) of the Finance Act 1972 viz.:—The Value Added Tax (Cars) Order 1972.

This Order disallows deduction of input tax on new motor cars acquired by taxable persons for use in their business and on used motor cars. The disallowance does not apply to new cars acquired for sale, to cars intended for conversion into another kind of vehicle or to the charge for the hiring of a car.

The Order also brings within the tax certain motor cars which are self-supplied by taxable per ons for their own use, and places such cars in the same position as other cars as regards disallowance of input tax. These provisions continue those contained in the Value Added Tax (Self-Supply) (No. 1) Order 1972 which is revoked. The Order further provides, subject to specified conditions, for the tax chargeable on the supply (otherwise than by hiring) of a used car by a taxable person to be charged only on the excess, if any, of the price which that person obtains for the car over the price which he gave for it.

The Order comes into operation on 1st April 1973 and has been published as Statutory Instrument 1972 No. 1970.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Sections 3(6) and 14 of the Finance Act 1972 viz.:—The Value Added Tax (Works of Art, Antiques and Scientific Collections) Order 1972.

This Order provides, subject to specified conditions, for the tax chargeable on the supply (otherwise than by hiring) of certain works of art, antiques and scientific collections by a taxable person to be charged only on the excess if any of the price which that person obtains for any item over the price which he gave for it.

The Order applies only to items which have been sold at least once before 1st April 1973 or have been sold at least once after that date by a seller who did not charge value added tax.

The Order also relieves from the tax imports of such items, provided, in the case of the works of art, that they have been acquired from the artist of his estate before 1st April 1973.

The Order comes into operation on 1st April 1973 and has been published as Statutory Instrument 1972 No. 1971.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 1, 2 and 13 of the Import Duties Act 1958.

Viz.:-The Import Duties (General) (No. 4) Order 1972.

This Order, which comes into operation on 1st February 1973, further amends the Import Duties (General) (No. 7) Order 1971, which sets out the United Kingdom Customs Tariff and the protective import duties chargeable in accordance with it.

This Order (Schedules 1 and 2) amends the manner in which most of the headings in Chapters 1-24, and a few headings in certain other Chapters, of the United Kingdom Tariff are at present sub-divided.

The Order (in Article 2(b)) provides for the conversion of sums expressed in units of account of the Community into pounds sterling where goods are defined by reference to such units of account in the new nomenclature.

These amendments stem from the United Kingdom's obligations under the Treaty of Accession to the European Economic Community to incorporate within the United Kingdom Tariff the subheadings of the Community's Common Customs Tariff in respect of agricultural products covered by a common organisation of the market and of certain other products by 1st February 1973. In the case of some goods, generally as a result of the United Kingdom's Treaty obligations, protective import duties are removed or reduced (Schedule 1 and Article 3).

The Order also provides for a change from imperial to metric units in some rates of duty (Schedule 3) and some descriptions of goods (Schedule 4).

The Order comes into operation on 1st February 1973 and has been published as Statutory Instruments 1972 No. 1909.

# THE GLASGOW RENFREW MOTORWAY (STAGE 2) (CONNECTING ROADS) SPECIAL ROADS SCHEME 1972

### ROADS (SCOTLAND) ACT 1970 THE CRAIGEND TO BROXDEN SPECIAL ROAD

THE Secretary of State has made the following Schemes and Order:—

- 1. A scheme for a special road (motorway) from Craigend on the outskirts of Perth to a point on the Stirling-Perth Trunk Road (A.9) near Broxden Farm, Perthshire. The scheme provides for the special road to become a trunk road, and that it will be for use only by motorway classes of traffic.
- 2. A scheme for 2 lengths of special road (motorway) to connect the Craigend to Broxden special road with the Muirmont to Craigend special road at a grade-separated junction at Craigend. The scheme also provides that the special roads shall be trunk roads and that they will be for use only by motorway classes of traffic.
- 3. An order for altering or stopping-up roads, constructing new roads, stopping-up private means of access and providing new means of access all on or in the vicinity of the route of the Craigend to Broxden special road. The Joint County Council of Perth and Kinross will become the highway authority for the new roads.

With the Craigend to Barnhill Special Road Scheme 1972 and its associated scheme and orders, these schemes and the order set out the arrangements for the construction of a southern bypass of the town of Perth.






