A PROCLAMATION

ELIZABETH R.

Whereas by Section 1 of the Emergency Powers Act 1920, as amended by the Emergency Powers Act 1964, it is enacted that if it appears to us that there have occurred or are about to occur events of such a nature as to be calculated, by interfering with the supply and distribution of food, water, fuel or light, or with the means of locomotion, to deprive the community, or any substantial portion of the community, of the essentials of life, we may, by Proclamation, declare that a state of emergency exists:

And, whereas, on the 13th day of November 1973, we made, in pursuance of the said Act of 1920, as so amended, a Proclamation declaring that the present Industrial disputes affecting persons employed in the coal mines and in the electricity supply industry did, in our opinion, constitute a state of emergency within the meaning of that Act:

And whereas, by virtue of Section 1 of the said Act of 1920, a Proclamation issued in pursuance thereof does not remain in force for more than one month:

And whereas the continuance of the said Industrial disputes, the present Industrial dispute affecting persons employed on the railways and the reduction in oil supplies reaching Great Britain do, in our opinion, constitute a state of emergency within the meaning of the said Act of 1920:

Now, therefore, in pursuance of the said Act of 1920, we do, by and with the advice of Our Privy Council, hereby declare that a state of emergency exists.

Given at Our Court at Buckingham Palace this twelfth day of December in the year of Our Lord one thousand nine hundred and seventry-three, and in the twenty-second year of Our Reign.

Draft Coal and Other Mines (Support) (Amendment)
Regulations 1974

THE Secretary of State for Trade and Industry, in accordance with the provisions of Section 142 and Part I of the Second Schedule to the Mines and Quarries Act 1954, hereby gives notice that he proposes to make General Regulations under Sections 49, 54, 141 and 143 of the Mines and Quarries Act 1954 entitled the Coal and Other Mines (Support) (Amendment) Regulations 1974.

The draft regulations amend the Coal and Other Mines (Support) Regulations 1966 which apply to mines of coal, shale and firecay; the effect of this amendment is to substitute metric measurements for the imperial measurements quoted in the 1966 regulations. The new measurements will apply to all workings begun 3 months after the regulations come into force and to any existing workings elected by the manager of the mine to be workings to which the regulations apply.

Note: —The Scheme which follows this note is made under section 28 of the Post Office Act 1969 and amends the provisions of the Post Office Inland Post Scheme 1972 relating to registered newspapers and supplements and increases the limits of size of parcels. It comes into operation on 17th December 1973.

THE POST OFFICE INLAND POST

AMENDMENT (No. 4) SCHEME 1973

Made ... 13th November 1973

Coming into operation 17th December 1973

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, citation and interpretation

- 1.—(1) This Scheme shall come into operation on the 17th day of December 1973 and may be cited as the Post Office Inland Post Amendment (No. 4) Scheme 1973.
- (2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1972 (Post Office Scheme P7/1972) (hereinafter called "the Scheme") as amended by the Post Office Inland Post Amendment (No. 1) Scheme 1973 (Post Office Scheme P1/1973), the Post Office Inland Post Amendment (No. 2) Scheme 1973 (Post Office Scheme P10/1973) and the Post Office Inland Post Amendment (No. 3) Scheme 1973 (Post Office Scheme P11/1973).
- (3) The Interpretation Act 1889 applies for the interpretation of this Sch.me as it applies for the interpretation of an Act of Parliament and as if this Scheme were an Act of Parliament.

Registered Newspapers

- 2.—For sub-paragraph (6) of paragraph 21 of the Scheme there shall be substituted the following:
 - "(6) A publication shall be registrable under sub-paragraph (1) as a newspaper if—
 - (a) not less than one third of the publication consists of political or other news or of articles relating thereto or to other current topics; and
 - (b) it is printed on paper and published in the British postal area, the Channel Islands, the Isle of Man or in some other part of the Commonwealth, in a British Protected State, or in the Republic of Ireland; and
 - (c) it is published in numbers at intervals of not more than seven days; and
 - (d) it has
 - (i) the full title and the date of publication printed prominently on the first page, and
 - (ii) the whole or part of the title and the date of publication printed on every detached sheet which is issued as part of it,
 - (iii) the words "Registered as a newspaper at the Post Office" printed on it."
- 3.—For sub-paragraph (8) of paragraph 21 of the Scheme there shall be substituted the following:
 - "(8) A publication shall be deemed to be a supplement to a registered newspaper if—
 - (a) it is published with an issue of a registered newspaper; and
 - (b) it is printed on paper and consists of matter like that of the newspaper, or of advertisements, or wholly or partly of pictorial matter illustrative of articles in the newspaper; and
 - (c) the heading "Supplement" is printed on every page; provided that in the case of a supplement consisting of
 - (i) several sheets bound together and separate from the newspaper itself it shall be sufficient if the heading "Supplement" and the whole or part of the title of the newspaper are printed only on the first page,
 - (ii) a sheet or sheets not bound together and separate from the newspaper itself it shall be sufficient if the heading "Supplement" and the whole or part of the title of the newspaper are printed on one side of every sheet; and
 - (d) all sheets of the publication are put together in some one part of that issue of the newspaper, whether gummed or stitched up with the newspaper or not; and
 - (e) the tital area of its pages does not exceed the total area of the pages of a copy of the issue of the newspaper with which it is published."
- 4.—For paragraph 22 of the Scheme there shall be substituted the following:
- "22.—(1) Every current registered newspaper shall be prominently marked on the outside (or, if covered, on the outside of the cover or envelope thereof) "Newspaper Post" and shall be subject to examination in the post, and if posted without a cover shall not be fastened or otherwise treated so as to prevent easy examination. The cover or envelope of a covered current registered newspaper shall be unfastened or (save as the Post Office may either generally or in any particular case allow) so adapted that the contents can be easily examined without breaking any seal, or tearing any paper, or cutting any string, or separating any surfaces.
- (2) Save as the Post Office may either generally or in any paritcular case allow, every current registered newspaper when posted shall be so folded and, if posted in a cover or envelope, so covered, as to permit the title and date of issue to be readily inspected.
- (3) There shall not be posted in, with, or in the same cover or envelope as, a current registered newspaper anything which would not be transmissible separately as such other than:
 - (a) a supplement which is part of that newspaper;
 - (b) not more than three advertising inserts each comprising a single sheet of paper or card of advertising matter and consisting wholly or in part of a card which is a preferred letter or a preferred envelope (but not a folder unless it is made to be sealed down along all edges), intended to be used to order or enquire by post about the goods or services advertised. The card or envelope must bear the correct postal address, including the postcode of the advertiser;

Provided that:

- (i) the supplement and advertising inserts must be the same in each copy of an issue of a current registered newspaper despatched to addresses in the United Kingdom
- (ii) the total area of the supplement and advertising inserts together must not exceed the total area of the pages of a copy of the issue of the newspaper with which they are despatched.
- (4) No current registered newspaper, and no cover or envelope in which it is enclosed, shall bear anything (not being part of the newspaper) except:
 - (a) the names, addresses and descriptions of the sender and addressee with index or reference numbers and letters;
 - (b) the words "With compliments", "Specimen copy" or "Voucher copy";
 - (c) the title of the newspaper, and a reference to its registration for transmission by post; and
 - (d) a reference to any page of or place in the newspaper to which the attention of the addressee is directed."
- 5.—Sub-paragraph (3) of paragraph 21 which is now spent, shall be regarded as having been repeated in this Scheme and once more operative.

- 6. In Column 3 of item 4 of Schedule 1 of the Scheme there shall be added after the words "6 feet" the words "7 inches".



DISEASES OF ANIMALS ACT 1950

NOTICE is hereby given in pursuance of Section 85(3) of the Diseases of Animals Act 1950 that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland, acting jointly, have made the following Order:—

Statutory Instruments 1973 No. 1936 The Diseases of Animals (Waste Food) Order 1973 (Made 16th November 1973)

This Order revokes and re-enacts, with amendments, the Diseases of Animals (Waste Foods) Order 1957.

The definition of waste food is extended to comprise:—

- (a) meat, or any other part of the carcase of any livestock or poultry, or any product derived therefrom or hatchery waste, eggs or egg shells, or
- (b) broken or waste foodstuffs which contain or have been in contact with meat or any other part of the carcase of any livestock or poultry.

Meal manufactured from protein originating from livestock or poultry is, however, excluded from the definition of waste food.

The principal requirements of the order are:—

(1) A prohibition on the possession of waste food which has not been processed as required by the order on any premises for the purpose of feeding to livestock or poultry on those premises, unless a licence granted under article 7 of the order is held, or the feeding to livestosk or poultry of waste food, or any feedingstuffs which have been in contact with waste food, unless such waste food or such feedingstuffs have first been processed by means of plant and equipment operated under a licence granted under article 7. (Article 3).

(These prohibitions do not, however, apply to the possession by any person of waste food originating from his own household, or to the use of such waste food provided it has first been processed as required by the order.)

- (2) A complete prohibition is imposed upon the feeding to any animal, poultry or other birds of any waste food brought into Great Britain as part of the stores on a ship, aircraft etc. or of any other waste food which has been in contact with such imported stores. (Article 4).
- (3) Restrictions are placed upon the movement of unprocessed waste food intended for livestock or poultry except onto premises in respect of which a licence is held under article 7 or article 8 (except in the case of waste food intended for manufacture into meal) and upon access to or contact with unprocessed waste food. (Articles 5 and 6).

Restrictions are also imposed in respect of movement of waste food by road, and as to the distribution of processed waste food. (Articles 9 and 10).

The Schedules to the order set out specifications for premises on which processing of waste food is licensed or on which unprocessed waste food may be collected for further distribution, and also operating conditions required at premises of both types.
