

Coming into operation 19th March 1975 At the Court at Buckingham Palace, the 18th day of March 1975 Present,

The Queen's Most Excellent Majesty in Council

Her Majesty, by virtue and in exercise of the powers conferred on Her by section 205(3) and (7) of the Local Government (Scotland) Act 1973(a), is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

- 1. This Order may be cited as the Lord-Lieutenants Order 1975 and shall come into operation on 19th March 1975.
- 2. The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. Any lieutenant named in column (1) of Part I or of Part II of the Schedule to this Order or any person appointed in succession to him in the office described in relation to him in column (2) of the said Part I or of the said Part II, who holds that office immediately before the 16th May 1975, shall on and after that date continue to hold office as Lord-Lieutenant for that part of the region or the islands area specified, in relation to such existing office, in column (3) of the said Part I or of the said Part II, as the case may be.
- 4. Any person appointed under section 205(1) of the Local Government (Scotland) Act 1973 to the office of Lord-Lieutenant for a region, in succession to the holder or to the successor of the holder of an existing office described in column (2) of Part I of the said Schedule, shall exercise his functions in that part of the region, specified, in relation to such existing office, in column (3) of the said Part I.

EXPLANATORY NOTE

(This Note is not part of the Order)

Under section 205(1) of the Local Government (Scotland) Act 1973 lord-lieutenants are to be appointed for each region of Scotland to such number as Her Majesty may think fit, and also for each islands area. Under section 205(3) lord-lieutenants appointed for a region are to discharge their functions in such parts of the region as may be determined by Order in Council. Under section 205(7) lieutenants holding office immediately before 16th May 1975 (heretofore generally known as Lord Lieutenants) are to continue in office on and after that date for specified parts of a region, or for islands areas, as determined by Order in Council. This Order effects the appropriate assignments under both provisions.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 21st March 1975, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act 1877, and the National Loans Act 1968, to the amount of £120,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the Tenderer on any business day from Monday, the 24th March 1975, to Thursday, the 27th March 1975 inclusive and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
 9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.


