THE TRUNK ROADS (GALASHIELS) (PROHIBITION OF WAITING AND LOADING) ORDER 1975

TRUNK ROADS ACT 1946 SPECIAL ROADS ACT 1949 ROADS (SCOTLAND) ACT 1970 THE ARLARY TO MUIRMONT SPECIAL ROAD

THE Secretary of State has made the following Scheme:-

A Scheme for 3 lengths of special road (motorway) to connect the proposed Arlary to Muirmont Special Road with the existing Inverkeithing-Perth Trunk Road (A.90) at Muirmont. The Scheme also provides that the special roads shall be trunk roads and that they will be for use only by motorway classes of traffic.
