

The QUEEN has been pleased by Warrant under Her Majesty's Royal Sign Manual, bearing the date 13th May 1975, to appoint Quintin Campbell Wilson, Esquire, Chief Constable of the Ayrshire Constabulary, to be Inspector of Constabulary for Scotland as from 16th May 1975.




