THE TRUNK ROADS (GLENLUCE)
(RESTRICTION ON WAITING) ORDER 1975

THE Secretary of State proposes to make an Order imposing waiting restrictions on lengths of the trunk road (Route A.75) on Main Street, Glenluce between points 47 yards south west of the junction with Church Street and 63 yards north east of the junction with North Street. The order will provide exceptions for a vehicle to wait as long as necessary for a person to board or alight, to be used in connection with maintenance operations and other works and to enable goods to be loaded or unloaded. Disabled persons would also be exempted.

Full details of the proposals are contained in the draft Order which together with a plan showing the lengths of road involved and a statement of the Secretary of State's reasons for proposing to make the order may be examined during normal office hours at:—
