**WAGES COUNCILS ACT 1959**

**APPOINTMENT OF A COMMISSION OF INQUIRY**

WHEREAS the Secretary of State for Employment (hereinafter referred to as the "Secretary of State") pursuant to section 4 of, and the First Schedule to, the Wages Councils Act 1959 published in the *London and Edinburgh Gazettes* dated 25th June 1974 and again on 1st November 1974 notices of his intention to make an Order abolishing the Industrial and Staff Canteen Undertakings Wages Council and made available copies of a draft of the said Order ;

And Whereas in view of objections made with respect to the draft Order the Secretary of State has decided to refer the draft Order to a Commission of Inquiry for inquiry and report ;

And Whereas, where the Secretary of State refers a draft Order to a Commission of Inquiry as aforesaid, he is required by the First Schedule to the said Act to notify to the Commission the objections which he wishes the Commission to take into account ;

Now Therefore the Secretary of State in pursuance of the powers conferred upon him by sections 6 and 9 of, and the First and Fourth Schedules to, the said Act and after consultation with organisations representing employers and workers respectively in accordance with paragraph 3 of the said Fourth Schedule, hereby appoints the following persons to be members of a commission of inquiry :

Mr Jacob Glyndwr Picton, C.B.E., M.Com.
- (b) Person chosen to represent employers :  
Mr Herbert Leonard Farrimond, B.A.(Hons.)
- (c) Person chosen to represent employed persons :  
Mr George Fenwick Smith, C.B.E.

And the Secretary of State further appoints Professor H. A. Clegg to be Chairman of the Commission and Mr J. G. Picton to act as deputy chairman in the absence of the chairman ;

And the Secretary of State in pursuance of paragraph 5(b) of the said First Schedule hereby refers to the Commission the said draft Order for inquiry and report ;

And the Secretary of State, pursuant to paragraph 6 of the First Schedule, hereby notifies the Commission that the objections which he wishes the Commission to take into account are the objections set out in the Schedule hereto.

*Commission of Inquiry*

IN pursuance of the powers conferred on him by sections 4 and 9 of, and the First and Fourth Schedules to the Wages Councils Act 1959 (hereafter referred to as "the Act" the

Secretary of State for Employment (hereafter referred to as "the Secretary of State") has appointed a Commission of Inquiry and has referred to it for inquiry and report a draft Order abolishing the Industrial and Staff Canteen Undertakings Wages Council. Pursuant to paragraph 6 of the First Schedule to the Act the Secretary of State has notified to the Commission objections to the draft Order which he wishes the Commission to take into account, namely, objections received from the undermentioned organisations following the publication in this Gazette on 25th June 1974 and again on 1st November 1974 of notice of his intention to make the Order:

**THE TAYSIDE REGIONAL COUNCIL  
ROAD TRAFFIC REGULATION ACT, 1967  
The Tayside Region (Reform Street, Dundee)  
(Traffic Restriction) Order 1975**

1. THE Tayside Regional Council propose to make an Order under Section 1(1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968 and further amended by Section 133 of the Local Government (Scotland) Act 1973.

- (d) the conveyance of goods or merchandise to or from any premises situated on or adjacent to that length of road;

provided always that such excepted vehicles shall proceed in that length of road only in a northerly direction, i.e. from High Street towards Bank Street.

3.
